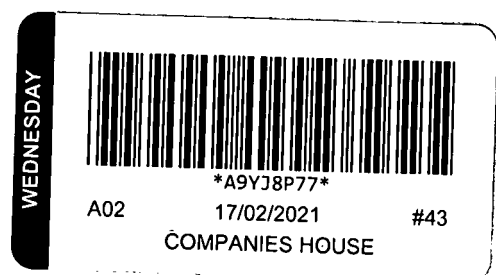

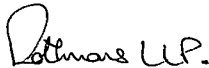

**1. STATUTORY INFORMATION**
