1 ULTIMATE PARENT COMPANY

The Company's immediate parent company and controlling undertaking is Willis Group Limited. The Company's ultimate parent company and controlling party was Willis Group Holdings Limited, a company incorporated in Bermuda. On 31st December 2009 the Group redomiciled its ultimate parent company to Ireland. As a result Willis Group Holdings plc, a company incorporated in Ireland, replaced Willis Group Holdings Limited as the ultimate parent company, whose group financial statements are available from the Company Secretary, 51 Lime Street, London EC3M 7DQ.
