ORDER

UPON the application of Lauren Louise Auburn, John William Rimmer,
Thomas Edward Guthrie, Sukhvinder Kaur Bains and Peter John Windatt
(the "**Application**")

AND UPON reading the witness statements of Peter John Windatt, Lauren Louise Auburn, John William Rimmer, Thomas Edward Guthrie and Sukhvinder Kaur Bains

IT IS ORDERED THAT:

1. The insolvency proceedings listed in the Schedules attached hereto which are not currently before the High Court of Justice ("**High Court**") be transferred to the High Court for the purposes of the Application only, and the Applicants do ensure that a sealed copy of this Order be lodged with the Court having jurisdiction over each case affected by this Order and is notified to the Secretary of State.
2. The First Respondent, Peter John Windatt, is removed from his office as Administrator in respect of the company in Administration which is set out in Schedule A attached hereto.
3. The First Applicant, Lauren Louise Auburn, is appointed as Administrator in substitution of the First Respondent in respect of the company which is set out in Schedule A attached hereto. In the event that the said company goes into voluntary liquidation the Court hereby appoints the First Applicant, Lauren Louise Auburn, to be a liquidator with effect from the date of liquidation. For the avoidance of doubt, nothing in this Order shall prevent the creditors of the company from seeking to exercise their power to nominate another person as proposed liquidator pursuant to paragraph 83(7)(a) of Schedule B1 of the Insolvency Act 1986, or section 139(3) of the Insolvency Act 1986.
4. The First Respondent, Peter John Windatt, is removed from his office as Liquidator in respect of the companies in Creditors' Voluntary Liquidation which are set out in Schedule B attached hereto.
5. The First to Fourth Applicants, Lauren Louise Auburn, John William Rimmer, Thomas Edward Guthrie and Sukhvinder Kaur Bains, are appointed as Liquidator in substitution of the First Respondent in respect of the companies which are set out in Schedule B attached hereto where they are identified as proposed appointee.
6. The First Respondent, Peter John Windatt, is removed from his office as Liquidator in respect of the limited liability partnerships

in Creditors' Voluntary Liquidation which are set out in Schedule C attached hereto.

7. The First and Third Applicants, Lauren Louise Auburn and Thomas Edward Guthrie, are appointed as Liquidator in substitution of the First Respondent in respect of the limited liability partnerships which are set out in Schedule C attached hereto where they are identified as proposed appointee.
8. The First Respondent, Peter John Windatt, is removed from his office as Liquidator in respect of the companies in Members' Voluntary Liquidation which are set out in Schedule D attached hereto.
9. The First to Fourth Applicants, Lauren Louise Auburn, John William Rimmer, Thomas Edward Guthrie and Sukhvinder Kaur Bains, are appointed as Liquidator in substitution of the First Respondent in respect of the companies which are set out in Schedule D attached hereto where they are identified as proposed appointee.
10. The First Respondent, Peter John Windatt, is removed from his office as Liquidator in respect of the companies in Compulsory Liquidation which are set out in Schedule E attached hereto.
11. The First Applicant, Lauren Louise Auburn, is appointed as Liquidator in substitution of the First Respondent in respect of the companies which are set out in Schedule E attached hereto.
12. The First Respondent, Peter John Windatt, is removed from his office as Supervisor in respect of the companies in Company Voluntary Arrangements which are set out in Schedule F attached hereto.
13. The First Applicant, Lauren Louise Auburn, is appointed as Supervisor in substitution of the First Respondent in respect of the companies in Company Voluntary Arrangements which are set out in Schedule F attached hereto.
14. The First Respondent, Peter John Windatt, is removed from his office as Trustee in Bankruptcy in respect of the individuals who are set out in Schedule G attached hereto.
15. The First to Third Applicants, Lauren Louise Auburn, John William Rimmer and Thomas Edward Guthrie, are appointed as Trustee in Bankruptcy in substitution of the First Respondent in respect of

the individuals who are set out in Schedule G attached hereto where they are identified as proposed appointee.

16. The First Respondent, Peter John Windatt, is removed from his office as Supervisor in respect of the Individual Voluntary Arrangement which is set out in Schedule H attached hereto.
17. The First Applicant, Lauren Louise Auburn, is appointed as Supervisor in substitution of the First Respondent in respect of the individual who is in the Individual Voluntary Arrangement which is set out in Schedule H attached hereto.
18. The Applicants shall procure that, at the first convenient opportunity to do so, and in any event within 3 months of the date of this Order, a block advertisement in respect of each of the insolvency appointments listed in Schedules A, B, C, D, E, F, G and H shall be placed in the London Gazette containing notification of the following matters:
 - 18.1 the removal of the First Respondent and the substitution of the First Respondent by one of the Applicants, as the case may be;
 - 18.2 that creditors (and members in the case of Members' Voluntary Liquidations) and debtors have liberty to apply within 28 days after the notice has been advertised, to object to the First Respondent's release;
 - 18.3 that in the case of the Liquidations and Bankruptcies listed in Schedules B, C, D, E and G, the First Respondent will be entitled to apply to the Secretary of State for his release upon the expiry of 42 days from the date the notice has been advertised, SAVE that in the event of an application in relation to one of the insolvency appointments has been made by a creditor, a member in the case of Members' Voluntary Liquidations, or a debtor, within the relevant time period, objecting to the said release, the First Respondent will not seek to apply for his release in relation to that insolvency appointment until after the said application has been disposed of (whether by agreement or by order of the Court); and
 - 18.4 that in the case of the Administration and Voluntary Arrangements listed in Schedules A, F and H, the First Respondent will be released from all liability both in respect of any of his acts and omissions in relation to his

conduct as office-holder of the estates with effect from 28 days from the date when the notice has been advertised, SAVE that in the event of an application in relation to one of the insolvency appointments has been made by a creditor or debtor, within the relevant time period, objecting to the said release, the First Respondent will be released in relation to the said insolvency appointment 28 days after the said application has been disposed of (whether by agreement or by order of the Court) or further order of the Court in the meantime.

19. In relation to the insolvency proceedings listed in the Schedules hereto, and insofar as the Insolvency Act 1986 or the Insolvency (England and Wales) Rules 2016 contain any requirement for advertisement of the removal of the First Respondent or his substitution by the Applicants, compliance with paragraph 18 above shall be deemed as being sufficient compliance with any such advertisement provisions and for the avoidance of doubt, any further compliance with such notice provisions shall be waived. Insofar as the First Respondent is required by law to give any notice of his removal from office, the Applicants are entitled to sign and send any such notice on his behalf.
20. The period to be covered by progress reports to members and/or creditors and the dates by which those reports need to be sent to members and/or creditors and filed with the Registrar of Companies (if applicable) shall not be altered by virtue of the making of this Order or the replacement of the First Respondent by the Applicants, pursuant to this Order; and for the avoidance of doubt, any such requirement necessitating an alteration in the reporting dates by reason of the commencement, termination or replacement of an office-holder's appointment, are hereby waived.
21. In each of the Liquidations and Bankruptcies listed in Schedules B, C, D, E and G, the First Respondent shall be at liberty to apply to the Secretary of State for his release upon the expiry of 42 days from the date when the relevant notice referred to in paragraph 18 has been placed in the London Gazette, SAVE that in the event of an application in relation to one of the insolvency appointments has been made by a creditor, a member in the case of Members' Voluntary Liquidations, or a debtor, within the relevant time period, objecting to the said release, the First Respondent will not seek to apply for his release in relation to that insolvency appointment until after the said application has

been disposed of (whether by agreement or by order of the Court).

22. In the case of the Administration and Voluntary Arrangements listed in Schedules A, F and H, the First Respondent will be released from all liability both in respect of any of his acts and omissions in relation to his conduct as office-holder of the estates with effect from 28 days from the date when the relevant notice referred to in paragraph 18 above has been placed in the London Gazette, SAVE that in the event of an application in relation to one of the insolvency appointments has been made by a creditor or debtor, within the relevant time period, objecting to the said release, the First Respondent will be released in relation to the said insolvency appointment 28 days after the said application has been disposed of (whether by agreement or by order of the Court) or further order of the Court in the meantime.
23. In respect of the company listed in Schedule A, and solely for the purposes of rule 12.37(5) of the Insolvency (England and Wales) Rules 2016, the First Respondent shall be treated as being joined as an Applicant for the purpose of seeking the replacement of the First Respondent.
24. The costs of and occasioned by the Application shall be paid by BRI Business Recovery and Insolvency.
25. There be liberty to apply.
