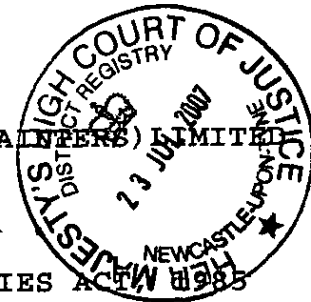

(B) inform the Registrar of Companies immediately on the conclusion of the said proposed litigation or any appeal therefrom or on the conclusion of the claim by any other means.

THIS COURT DOTH ORDER that the name of the above named A.and B.(Painters)Limited be restored to the Register of Companies

AND IT IS ORDERED that an Office Copy of this Order to be delivered to the Registrar of Companies AND pursuant to the above mentioned Act the said A.and B.(Painters)Limited is thereupon to be deemed to have continued in existence as if its name had not been struck off

AND IT IS ORDERED that the Registrar of Companies do

advertise notice of this Order in his official name in the  
"London Gazette"

AND IT IS ORDERED that the Claimant Anthony Appleby do pay  
to the Registrar of Companies his costs of the said Application  
in the agreed sum of £300-00.
