

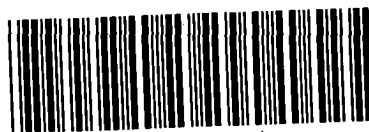

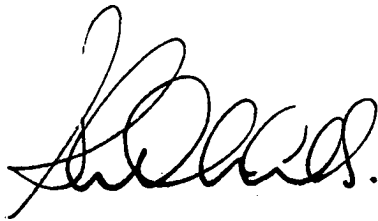
The directors have no beneficial interest in the shares of the company. The interests of the directors in the shares of the parent undertaking are shown in the directors' report of that company.

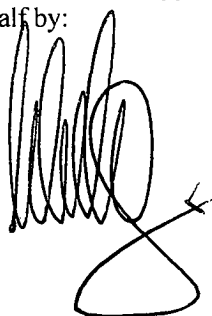
