1 Introduction

- This report is addressed to the creditors of VCS (Wayzgoose) Limited ("Wayzgoose"), VCS (Clearpoint) Limited ("Clearpoint") and Abbotts Creative Print Limited ("Abbotts") (collectively "the Group") and incorporates the Joint Administrators' proposals In accordance with Paragraph 52 (1)(b) of Schedule B1 of the Insolvency Act 1986, the Joint Administrators do not propose to call meetings of creditors to consider the proposals because there will be insufficient assets to enable us to make any distribution to unsecured creditors
- However, under Paragraph 52 of Schedule B1 of the Insolvency Act 1986 if at least 10% of creditors require us to call meetings they must notify us using form 2 21B (attached) by 30 November 2008 Please note that before such meetings can be held we will require a deposit towards the cost of convening the meetings Such deposit may be repaid if subject to approval of the other creditors
- The Joint Administrators would at some later date arrange for the Companies to exit Administration, as agreed by the creditors Based on the information presently available and the current situation the Joint Administrators' proposal is that the Companies will be dissolved once the Administrations are complete

2 Events leading up to the Appointment of the Joint Administrators

- Wayzgoose was incorporated on 2 November 1976 and Clearpoint on 4 July 1988, and traded respectively from freehold premises at East Road, Sleaford, Lincolnshire, NG34 7EH ("Sleaford Property") and freehold premises at Salop Street, Daybrook, Nottingham, Nottinghamshire, NG5 6HP ("Daybrook Property")
- Abbotts was incorporated on 1 May 1959 and traded from leasehold premises at Turnpike Close, Lutterworth, Leicestershire, LE17 4YB ("Lutterworth Property")



- 2 3 During July 2008 the Wayzgoose and Clearpoint operations were merged with the Clearpoint operation being relocated to the Sleaford Property Abbotts continued to trade from the Lutterworth Property as an independent business
- Following this merger the Daybrook Property was immediately marketed for sale with a sale being completed on 18 August 2008. The sale proceeds resulted in a surplus of £86k after repayment of the secured lending to HSBC Bank plc ("HSBC"). This surplus was paid into the Group's consolidated overdrawn banking facility with HSBC.
- The Group operated in the commercial printing sector predominantly undertaking the printing of greeting cards, digital printing, facilities management and a packaging operation to supplement the greeting cards business. The Group had an established customer base ranging from large multi-nationals to local Midlands based firms.
- The Group was financed by way of an invoice discounting facility with GE Commercial Finance Limited ("GE") and an overdraft facility with HSBC. Both GE's and HSBC's lending is subject to cross guarantees across the Group
- Wayzgoose also has an outstanding mortgage with HSBC, secured against the Sleaford Property
- Audited accounts for Wayzgoose for the year ended 30 June 2007 reported a reduced turnover of £5.1 million from £6 million during the prior year. This resulted in an operating loss of £187k being generated for the year compared to an operating loss of £147k in the prior period.
- Audited accounts for Clearpoint for the period from 1 March 2006 to 30 June 2007 reported increased turnover of £4 3 million from £3 7 million during the prior year. This resulted in an operating profit of £23k being generated for the period compared to an operating loss of £123k for the prior year.
- Audited accounts for Abbotts for the year ended 30 June 2007 reported increased turnover of £4 5 million from £4 1 million during the prior year. This resulted in an operating profit of £34k being generated for the period compared to an profit of £203k for the prior year.
- 2 11 Subsequent to the merger the Group appointed Savills (L&P) Limited ("Savills") to market the Sleaford Property with a view to relocating the Wayzgoose and Clearpoint operation This was in order to reduce costs and to generate funds for the Group
- 2 12 At this time the Group was suffering cash flow difficulties due to reduced levels of trading Consequently the Group was facing increasing pressure from creditors
- 2 13 Unable to fund the cash flow difficulties, the Directors filed a notice of intention to appoint Administrators in Court on 4 September 2008 in respect of the Group. This action provided an interim moratorium, protecting the Group from potential action.



- by creditors, whilst the viability of a sale of the businesses as a going concern was explored
- 2 14 On reviewing the Group's cash flow forecast and immediate purchasing requirements, it was apparent that only a short period of trading under the moratorium was viable Specifically, obtaining essential raw materials proved difficult as certain suppliers were unwilling to supply
- 2 15 With the support of key employees and two of the major customers, it was possible for the Group to fulfil sales orders. An extensive marketing campaign was undertaken in an attempt to sell the Group's business and assets on a going concern basis. Over 100 parties were identified as potential interested parties. Contact was made with these parties and an information memorandum circulated. Site visits were made by a number of interested parties as part of their due diligence process.
- 2 16 Unfortunately, no offers were received in respect of the Wayzgoose and Clearpoint operations Consequently the Directors confirmed that these companies should be placed into Administration with immediate effect
- 2 17 On 15 September 2008, notices of appointment were filed in respect of both Wayzgoose and Clearpoint, pursuant to Paragraph 22 of Schedule B1 of the Insolvency Act 1986 appointing Francis Graham Newton and myself as Joint Administrators
- Numerous parties did, however, express an interest in purchasing Abbotts both on a going concern and break up basis. Following extensive negotiations with a number of parties a going concern sale of the business and assets of Abbotts was completed to TWRM Print Limited ("TWRM") on 22 September 2008.
- 2 19 On 22 September 2008, a notice of appointment was filed in respect of Abbotts, pursuant to Paragraph 22 of Schedule B1 of the Insolvency Act 1986 appointing Francis Graham Newton and myself as Joint Administrators
- 2 20 At Appendix 1 is a record of the names of the Group's directors and company secretary's together with details of their shareholdings
- 3 Management of the Companies' affairs since the Joint Administrators' appointment
- 3 1 Initial Actions
- 3 1.1 Immediately following my appointment as Joint Administrator of Wayzgoose and Clearpoint my staff attended the Sleaford Property to advise all staff of the appointment
- 3 1 2 My staff undertook an immediate review of the affairs of these companies with particular regard to their financial and resource requirements. This assessment was carried out in liaison with the remaining management having regard to the ongoing business commitments and anticipated cash flows.



- It was apparent that significant purchases would have to be made to enable continued trading without the certainty of commensurate sales. It was therefore not deemed viable to continue trading during the Administration and trading ceased immediately upon my appointment with 123 of the 129 employees being made redundant. The remaining six staff were retained to provide assistance to the Administrators, update the Companies' accounting records and complete VAT and PAYE/NIC returns to HM Revenue & Customs.
- 3 1 4 Addleshaw Goddard LLP ("Addleshaw") were appointed as my solicitors
- 3 1 5 Savills were retained as agents to deal with the sale of the Sleaford Property Edward Symmons LLP ("Edward Symmons") were appointed as agents to deal with all other assets owned by Wayzgoose and Clearpoint Both agents undertook an independent valuation and review of the property and assets shortly following my appointment
- 3 2 Sale of the Abbotts business and assets
- 3 2 1 The sale of the business and assets of Abbotts to TWRM was completed immediately on my appointment
- 3 2 2 The total consideration to be paid is £80k plus VAT, of which £50k was received on completion. The remaining £30k is due to be paid in three instalments of £10k, due on 24 October, 24 November and 24 December 2008. A cheque for the initial instalment of deferred consideration has been received.
- 3 2 3 The consideration will be attributable as follows -

- 3 2 4 The benefits of selling the business as a going concern have been -
 - Protection of 33 jobs,
 - Minimisation of preferential and non-preferential claims,
 - Novation of key finance agreements, and
 - Protection of book debt realisations.



- 3 2.5 The sales ledger was not included in the sale but TWRM is assisting with collection of the ledger
- 3 2 6 TWRM has been granted a three month licence to occupy the Lutterworth Property, during which time we expect an assignment of the lease to be completed

3 3 The Sleaford Property

- 3 3 1 Prior to my appointment, Savills had been instructed in May 2008 to market the Sleaford Property for sale as part of their intention to relocate and merge the Group to one location
- 3 3 2 Savills had marketed the premises and initially advised a guide price of £1 25 million. A prior valuation carried out in April 2007 by Sanderson Weatherall, on behalf of HSBC, valued the Sleaford Property at circa £1 1 million. Conditional offers were apparently received for the property, but were dependent on certain planning permission being obtained for alternative use.
- 3 3 3 HSBC has an outstanding loan secured against the Sleaford Property The details of the amounts outstanding and security are outlined later in this report. It is not anticipated that HSBC's lending will be repaid in full from the sale of the property
- 3 3 4 Savills have continued to market the property Upon the advice of my agents, and with consent of HSBC, the property is scheduled to be placed at auction on 11 December 2008

3 4 Book debts

- The Group operated an invoice discounting facility with GE in respect of the sales ledgers. At the date of my appointment the outstanding book debts of Wayzgoose, Clearpoint and Abbotts were £1,190k, £249k and £435k respectively. The outstanding balances due to GE on each account at the date of my appointment were £676k, £328k and £349k respectively.
- 3 4 2 Legal and Receivables Limited, trading as Largo ("Largo"), were appointed by GE shortly following my appointment to collect the book debts of Wayzgoose and Clearpoint The collection fees of Largo are to be agreed directly with GE TWRM continue to collect the debts of Abbotts on behalf of GE
- All debtor realisations have been banked directly with GE to date The realisations for Wayzgoose, Clearpoint and Abbotts have been £533k, £72k and £266k respectively
- 3 4 4 Largo anticipate that the amounts due to GE should be fully repaid from the collective debtor realisations of the Group.



- 3 5 Plant, machinery, office furnishings and equipment
- 3 5 1 Edward Symmons were immediately instructed to value and market the assets of the Group
- 3 5 2 The going concern valuations attributed to the unencumbered plant, machinery and office furnishings and equipment of Wayzgoose and Clearpoint were £35k and £7k respectively Forced sale valuations were £20k and £4k respectively
- 3 5 3 Edwards Symmons are continuing to seek purchasers for these assets There have been no realisations in this respect to date and the assets will shortly be placed at auction
- 3 5 4 Edward Symmons continue to liaise with third party financiers in terms of the collection of their assets. Valuations indicate that there is little, if any, surplus value in encumbered plant and machinery
- 3 6 Motor vehicles
- 3 6 1 Edward Symmons' valuation indicated £16k and £14k on a going concern and forced sale business respectively for the vehicles owned by Wayzgoose and Clearpoint Realisations in this respect are ongoing
- 4 Statement of Affairs and statutory information
- The directors have not submitted a statement of affairs to us at the time of this report although we understand this to be submitted shortly. A schedule of the Group's estimated assets and liabilities based upon management accounts is attached at Appendix 2.
- 5 Receipts and Payments account
- Attached at Appendix 3 is a copy of our latest receipts and payments account in respect of each company in the Group separately
- It should be noted that all debtor realisations have been paid directly to GE's invoice discounting facility bank account
- 6 Achieving the purpose of the administration
- The statutory purpose of an administration consists of three objectives, and we now address the progress that has been made in this respect
- (a) The first objective is the rescuing the company as a going concern (i e restructuring the company, resulting in the survival of the company) Given the lack of available funding this was not possible
- (b) The second objective is achieving a better result for the Group's creditors as a whole than would be likely if the company were wound up (without first being in



- administration) It is anticipated that this objective will be achieved through the sale of business and assets of Abbotts to TWRM
- (c) The final objective is realising property in order to make a distribution to one or more secured or preferential creditors. It is anticipated that this objective will also be achieved
- 7 Creditors' claims
- 7 1 Secured Creditors
- 7 1 1 HSBC has a legal mortgage charge dated 17 May 2007 over the Sleaford Property At the date of our appointment debts of approximately £767k and £98k remained outstanding, in respect of a loan and overdraft facility respectively.
- 7 1 2 An auction of the Sleaford Property is to be carried out on 11 December 2008. It is anticipated that insufficient funds will be realised to enable a repayment of HSBC's liabilities under their mortgage security. HSBC will therefore be required to call upon their floating charge security which is detailed below.
- GE has a fixed and floating charge dated 17 May 2007 over the Group Additional fixed and floating charges dated 23 June 2006, 19 August 2005 and 4 August 1999 are held in respect of Wayzgoose and Clearpoint The extent of the liability to GE at the date of appointment was detailed earlier in this report
- 7 1 4 HSBC also has a fixed and floating charge dated 17 May 2007 over the Group
- 7 1 5 A deed of priority was entered into by the Group, GE and HSBC on 17 May 2007 The deed specifies, in respect of the Group, that
 - a) GE has a first charge on any debt that is owed to the Group, to the extent of the total liability that is outstanding to GE
 - b) The liabilities of HSBC will be discharged from any surplus debtor realisations resulting, after the payment in full of GE's outstanding liabilities
 - c) The liabilities of HSBC will be initially repaid out of proceeds realised from any other asset of the Companies except book debts and plant and machinery
 - d) Any residual liabilities due to GE, which have not been repaid under their security over book debts, will be repaid out of any surplus realisations from any other asset of the Companies after HSBC have been fully repaid
- 7 1 6 It is unlikely that there will be sufficient funds to enable a distribution to HSBC under their floating charge security



7.1 7 A chattel mortgage dated 11 June 2008 is held by State Securities plc over the intellectual property rights, warranty, service and maintenance agreements of Abbotts

72 Preferential Creditors

- 7 2 1 Preferential claims would only typically arise in respect of employee's arrears of wages and unpaid holiday pay
- 7 2 2 Due to immediate cessation of trade as at the date of appointment, 123 employees of Wayzgoose and Clearpoint were made redundant on 15 September 2008 Six employees were retained for a short period, ultimately being made redundant on 26 September 2008
- 723 There will be no preferential claims against Abbotts due to all employees being transferred to TWRM under the Transfer of Undertakings (Protection of Employment) Regulations
- 7 2 4 It is anticipated that insufficient funds will be realised to enable a dividend to preferential creditors

7.3 Unsecured claims

- 7 3 1 A summary of known trade creditors for Wayzgoose, Clearpoint and Abbotts is attached at Appendix 2 Please note that these figures are those initially provided by the Companies and should creditor's claims differ this will not affect their ability to claim for the full amount due to them
- 7 3 2 I currently await clarification of the debts due by each company to HM Revenue and Customs, in respect of unpaid PAYE/NIC deductions and VAT
- 7 3 3 At this stage it is anticipated that insufficient funds will be realised to enable a dividend to be paid to unsecured creditors of the Group
- 7 3 4 Eight claims have been received from suppliers to Wayzgoose and Clearpoint in respect of retention of title ("ROT") claims Addleshaw have assisted in verifying the validity of claims. To date two claims have been deemed valid and the remainder rejected. Valid claims will be dealt with by the Administrators.
- 7 3 5 The potential exposure to ROT claims was significantly reduced due to Wayzgoose and Clearpoint having to obtain supplies on a proforma basis for a number of months prior to my appointment
- 7 3 6 It is a condition of the sale and purchase agreement that TWRM deal directly with any ROT claim made by a supplier of Abbotts



74 Prescribed Part

7 4 1 Under the provisions of Section 176A of the Insolvency Act 1986 the Joint Administrators must state the amount of funds available to unsecured creditors in respect of the prescribed part. This provision only applies where the Companies have granted a floating charge to a creditor after 15 September 2003. It is unlikely there will be sufficient realisations to enable a dividend to made to unsecured creditors under the prescribed part.

8 EC Regulations on Insolvency Proceedings

We are required under the Insolvency Rules 1986 to state whether and if so the extent to which the above regulations apply to these administrations. In these particular cases the EC Regulation will apply in respect of the administrations and these proceedings will be main proceedings as provided by Article 3 of the aforesaid Regulation.

- Attached at Appendix 5 are schedules summarising the time that has been spent in administering these Administrations up to 10 November 2008
- 9 3 For your guidance I attach at Appendix 6 a Creditors' Guide to Administrators' Fees together with a document that outlines the policy of BDO Stoy Hayward LLP in respect of fees and disbursements

10 Possible outcomes for the Companies and Creditors

The Insolvency Act 1986 and Insolvency Rules 1986 provide a variety of options regarding the possible exit routes for each company in the Group from the Administrations, being primarily a Company Voluntary Arrangement, Liquidation or dissolution. It is the Joint Administrators' recommendation and proposal, as detailed below, that once all assets have been realised and distributed in the Administrations that the Joint Administrators arrange for each company to be dissolved.

Statement of proposals under Paragraph 49 of Schedule B1 of the Insolvency Act 1986

In accordance with Paragraph 49 of Schedule B1 of the Insolvency Act 1986 the Joint Administrators make the following proposals for each company in the Group for achieving the purpose of the Administrations



Formal Proposals - the Joint Administrators propose that:

- (a) they continue to manage the affairs of the Group and realise assets in accordance with objective 2 of the statutory purpose for the Administrations, being a better result to creditors compared with liquidation, and
- (b) that should it be required each company in the Group exit the Administration by way of Creditors' Voluntary Liquidation, Francis Graham Newton and myself be appointed Joint Liquidators and they will act with joint and several liability,

(NB Please note that under Paragraph 83(7) of Schedule B1 of the Insolvency Act 1986 and Rule 2 117(3) of the Insolvency Rules 1986, creditors may nominate different liquidators provided that the nomination is made after receipt of the proposals but before such proposals are approved In the absence of such nominations, Francis Graham Newton and myself will be Joint Liquidators)

- (c) If, as is anticipated, realisations are insufficient to enable a dividend to be paid to non preferential creditors the Joint Administrators propose to exit the Administration by way of dissolution of the Company under Paragraph 84 of Schedule B1 of the Insolvency Act 1986,
- (d) they petition for the compulsory winding up of each company in the Group should the Joint Administrators conclude that additional investigations into the affairs of the Group is necessary, but that there are insufficient funds available to fund such investigations,
- (e) that the Joint Administrators of the Group be discharged from liability, pursuant to Paragraph 98 of Schedule B1 of the Insolvency Act 1986, in respect of any action of each or both of them as Joint Administrators immediately upon filing their final report and sending it to creditors,

Creditors' Guide to Administrators' Fees

1 Introduction

When a company goes into administration the costs of the proceedings are paid out of its assets. The creditors, who hope eventually to recover some of their debts out of the assets, therefore have a direct interest in the level of costs, and in particular the remuneration of the insolvency practitioner appointed to act as administrator. The insolvency legislation recognises this interest by providing mechanisms for creditors to determine the basis of the administrator's fees. This guide is intended to help creditors be aware of their rights under the legislation to approve and monitor fees and explains the basis on which fees are fixed.

2 The nature of administration

- Administration is a procedure which places a company under the control of an insolvency practitioner and the protection of the court with the following objective
 - rescuing the company as a going concern, or
 - achieving a better result for the creditors as a whole than would be likely if the company were wound up without first being in administration,

or, if the administrator thinks neither of these objectives is reasonably practicable

realising property in order to make a distribution to secured or preferential creditors

3 The creditors' committee

3.1 The creditors have the right to appoint a committee with a minimum of 3 and a maximum of 5 members. One of the functions of the committee is to determine the basis of the administrator's remuneration. The committee is normally established at the meeting of creditors which the administrator is required to hold within a maximum of 10 weeks from the beginning of the administration to consider his proposals. The administrator must call the first meeting of the committee within 6 weeks of its establishment, and subsequent meetings must be held either at specified dates agreed by the committee, or when a member of the committee asks for one, or when the administrator decides he needs to hold one. The committee has power to summon the administrator to attend before it and provide information about the exercise of his functions.

4 Fixing the administrator's fees

- 4.1 The basis for fixing the administrator's remuneration is set out in Rule 2 106 of the Insolvency Rules 1986, which states that it shall be fixed either
 - as a percentage of the value of the property which the administrator has to deal with, or
 - by reference to the time properly given by the administrator and his staff in attending to matters arising in the administration

It is for the creditors' committee (if there is one) to determine on which of these bases the remuneration is to be fixed and, if it is fixed as a percentage fix the percentage to be applied. Rule 2 106 says that in arriving at its decision the committee shall have regard to the following matters.

- the complexity (or otherwise) of the case,
- any responsibility of an exceptional kind or degree which falls on the administrator,
- the effectiveness with which the administrator appears to be carrying out, or to have carried out, his
 duties,
- the value and nature of the property which the administrator has to deal with
- 4.2 If there is no creditors' committee, or the committee does not make the requisite determination, the administrator's remuneration may be fixed by a resolution of a meeting of creditors having regard to the same matters as the committee would If the remuneration is not fixed in any of these ways, it will be fixed by the court on application by the administrator

- There are special rules about creditors' resolutions in cases where the administrator has stated in his proposals that the company has insufficient property to enable a distribution to be made to unsecured creditors except out of the reserved fund which may have to be set aside out of floating charge assets. In this case a resolution of the creditors shall be taken as passed if, and only if, passed with the approval of
 - each secured creditor of the company, or
 - If the administrator has made or intends to make a distribution to preferential creditors each secured creditor of the company, and
 - preferential creditors whose debts amount to more than 50% of the preferential debts of the company, disregarding debts of any creditor who does not respond to an invitation to give or withhold approval

Note that there is no requirement to hold a creditors' meeting in such cases unless a meeting is requisitioned by creditors whose debts amount to at least 10 per cent of the total debts of the company

- 5 What information should be provided by the administrator?
- 5 1 When seeking fee approval
- When seeking agreement to his fees the administrator should provide sufficient supporting information to enable the committee or the creditors to form a judgement as to whether the proposed fee is reasonable having regard to all the circumstances of the case. The nature and extent of the supporting information, which should be provided, will depend on
 - the nature of the approval being sought,
 - the stage during the administration of the case at which it is being sought, and
 - the size and complexity of the case
- Where, at any creditors' or committee meeting, the administrator seeks agreement to the terms on which he is to be remunerated, he should provide the meeting with details of the charge-out rates of all grades of staff, including principals, which are likely to be involved on the case
- Where the administrator seeks agreement to his fees during the course of the administration, he should always 5 1 3 provide an up to date receipts and payments account. Where the proposed fee is based on time costs the administrator should disclose to the committee or the creditors the time spent and the charge-out value in the particular case, together with, where appropriate, such additional information as may reasonably be required having regard to the size and complexity of the case. The additional information should comprise a sufficient explanation of what the administrator has achieved and how it was achieved to enable the value of the exercise to be assessed (whilst recognising that the administrator must fulfil certain statutory obligations that might be seen to bring no added value for creditors) and to establish that the time has been properly spent on the case That assessment will need to be made having regard to the time spent and the rates at which that time was charged, bearing in mind the factors set out in paragraph 4 I above. To enable this assessment to be carried out it may be necessary for the administrator to provide an analysis of the time spent on the case by type of activity and grade of staff The degree of detail will depend on the circumstances of the case, and professional guidance has been provided setting out a minimum of 6 category headings under which the work done by the officeholder and his staff should be analysed As a firm BDO Stoy Hayward LLP operates a computerised time recording system which analyses work done under the following categories -
 - Pre Appointment Matters
 - Steps upon Appointment
 - Planning and Strategy
 - General Administration
 - Asset Realisation/Management

Professional guidance suggests the following categories as a basis for analysis by grade of staff

- Partner
- Manager
- Other senior professionals
- Assistants and support staff

The explanation of what has been done can be expected to include an outline of the nature of the assignment and the administrator's own initial assessment, including the anticipated return to creditors. To the extent applicable it should also explain

- Any significant aspects of the case, particularly those that affect the amount of time spent
- The reasons for subsequent changes in strategy
- Any comments on any figures in the summary of time spent accompanying the request the administrator wishes to make
- The steps taken to establish the views of creditors, particularly in relation to agreeing the strategy for the assignment, budgeting, time recording, fee drawing or fee agreement
- Any existing agreement about fees
- Details of how other professionals, including sub-contractors, were chosen, how they were contracted to be paid, and what steps have been taken to review their fees

It should be borne in mind that the degree of analysis and form of presentation should be proportionate to the size and complexity of the case. In smaller cases not all categories of activity will always be relevant, whilst further analysis may be necessary in larger cases.

Where the fee is charged on a percentage basis the administrator should provide details of any work which has been or is intended to be sub-contracted out which would normally be undertaken directly by an administrator or his staff

52 After fee approval

Where a resolution fixing the basis of fees is passed at any creditors' meeting held before he has substantially completed his functions, the administrator should notify the creditors of the details of the resolution in his next report or circular to them. In all subsequent reports to creditors the administrator should specify the amount of remuneration he has drawn in accordance with the resolution. Where the fee is based on time costs he should also provide details of the time spent and charge-out value to date and any material changes in the rates charged for the various grades since the resolution was first passed. He should also provide such additional information as may be required in accordance with the principles set out in paragraph 5.1.3. Where the fee is charged on a percentage basis the administrator should provide the details set out in paragraph 5.1.4 above regarding work which has been sub-contracted out.

5.3 Expenses and disbursements

There is no statutory requirement for the committee or the creditors to approve the drawing of expenses or disbursements. However, professional guidance issued to insolvency practitioners requires that, where the administrator proposes to recover costs which, whilst being in the nature of expenses or disbursements, may include an element of shared or allocated costs (such as room hire, document storage or communication facilities provided by the administrator's own firm), they must be disclosed and be authorised by those responsible for approving his remuneration. Such expenses must be directly incurred on the case and subject to a reasonable method of calculation and allocation.

6 What if a creditor is dissatisfied?

If a creditor believes that the administrator's remuneration is too high he may, if at least 25 per cent in value of the creditors (including himself) agree, apply to the court for an order that it be reduced. If the court does not dismiss the application (which it may if it considers that insufficient cause is shown) the applicant must give the administrator a copy of the application and supporting evidence at least 14 days before the hearing. Unless the court orders otherwise, the costs must be paid by the applicant and not as an expense of the administration.

7 What if the administrator is dissatisfied?

If the administrator considers that the remuneration fixed by the creditors' committee is insufficient he may request that it be increased by resolution of the creditors. If he considers that the remuneration fixed by the committee or the creditors is insufficient, he may apply to the court for it to be increased. If he decides to apply to the court he must give at least 14 days' notice to the members of the creditors' committee and the committee may nominate one or more of its members to appear or be represented on the application. If there is no committee, the administrator's notice of his application must be sent to such of the company's creditors as the court may direct, and they may nominate one or more of their number to appear or be represented. The court may order the costs to be paid as an expense of the administration.

8 Other matters relating to fees

- 8.1 Where there are joint administrators it is for them to agree between themselves how the remuneration payable should be apportioned. Any dispute arising between them may be referred to the court, the creditors' committee or a meeting of creditors.
- 8 2 If the administrator is a solicitor and employs his own firm to act on behalf of the company, profit costs may not be paid unless authorised by the creditors' committee, the creditors or the court

9 Provision of information – additional requirements

In any case where the administrator is appointed on or after 1 April 2005 he must provide certain information about time spent on a case, free of charge, upon request by any creditor, director or shareholder of the company. The information which must be provided is –

- the total number of hours spent on the case by the administrator or staff assigned to the case,
- · for each grade of staff, the average hourly rate at which they are charged out,
- the number of hours spent by each grade of staff in the relevant period

The period for which the information must be provided is the period from appointment to the end of the most recent period of six months reckoned from the date of the administrator's appointment, or where he has vacated office, the date that he vacated office

The information must be provided within 28 days of receipt of the request by the administrator, and requests must be made within two years from vacation of office

The rates charged by BDO Stoy Hayward LLP, 1 Bridgewater Place are reviewed in December and July each year and are adjusted to take account of inflation and the firm's overheads

Time spent on casework is recorded directly to the relevant case using a computerised time recording system and the nature of the work undertaken is recorded at that time. Units of time can be as small as 3 minutes. BDO Stoy Hayward LLP records work in respect of insolvency work under the following categories -

Steps upon Appointment
Planning and Strategy
General Administration
Asset Realisation/Management
Trading Related Matters
Employee Matters
Creditor Claims
Reporting
Distribution and Closure
Other Issues

Under each of the above categories the work is recorded in greater detail in sub categories. Please note that the 11 categories provide greater detail than the six categories recommended by the Recognised Professional Bodies who are responsible for licensing and monitoring insolvency practitioners.

Where an officeholder's remuneration is approved on a time cost basis the time invoiced to the case will be subject to VAT at the prevailing rate



Where remuneration has been approved on a time costs basis a periodic report will be provided to any committee appointed by the creditors or in the absence of a committee to the creditors. The report will provide a breakdown of the remuneration drawn and will enable the recipients to see the average rates of such costs.

Other Costs

Where expenses are incurred in respect of the insolvent estate they will be recharged. Such expenses can be divided into two categories

Category 1

This heading covers expenses where BDO Stoy Hayward LLP has met a specific cost in respect of the insolvent estate where payment has been made to a third party. Such expenses may include items such as advertising, couriers, travel (by public transport), searches at Companies House, land registry searches, fees in respect of swearing legal documents, external printing costs etc. In each case the recharge will be reimbursement of a specific expense incurred.

A further disbursement under this heading is the cost of travel where staff use either their own vehicles or company cars in travelling connected with the insolvency. In these cases a charge of 40p per mile is raised which is in line with the Inland Revenue Approved Mileage Rates (median – less than 10,000 miles per annum) which is the amount the firm pays to staff

Where applicable, disbursements will be subject to VAT at the prevailing rate

Category 2

Additionally some firms recharge expenses for example postage, stationery, photocopying charges, telephone and fax costs, which cannot economically be recorded in respect of a each specific case. Such expenses, which are apportioned to cases, require the approval of the creditors, before they can be drawn, and these are known as category 2 disbursements. The policy of BDO Stoy Hayward LLP, effective from 1 July 2003, is not to recharge any expense which is not a specific cost to the case, therefore there will be no category 2 disbursements charged. Category 2 disbursements, because they are imprecise, require approval by the creditors before they can be drawn.
