Deed of Covenants dated 11 November 1974 in respect of each of the Vessels "ATLANTIC PHOENIX" and "DART AMERICA"

Rider

- (a) All policies and contracts of insurance (including all entries of the Vessels "ATLANTIC PHOENIX" and "DART AMERICA" (together the "Ships") in a protection and indemnity or war risks association) which are from time to time taken out or entered into in respect of the Ships (or either of them) and all benefits thereof (including claims of whatsoever nature and return of premiums);
- (b) All freight, hire and passage moneys, compensation payable to the Company in the event of the requisition of the Ships Vessel "DART AMERICA" for hire, remuneration for salvage and towage services, demurrage and detention moneys and any other earnings whatsoever due or to become due to the Company during the continuance of the Mortgage.
- (c) All moneys or other compensation payable during the continuance of the Mortgage by reason of requisition for title or other compulsory acquisition of the Ships (or either of them) otherwise than by requisition for hire.
