Notes to the Abbreviated Accounts

For the year ending 31 August 2009

1 **Accounting policies**

Basis of accounting

The financial statements have been prepared under the historical cost convention, modified to include the revaluation of certain fixed assets, and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008).

Turnover

Turnover shown in the profit and loss account represents rent receivable for the year.

Depreciation

Investment properties Completed investment properties are included in the balance sheet at their open market value. The valuations are carried out annually by the directors in accordance with the Financial Reporting Standard for Smaller Entities (effective Jan 2008) (FRSSE) and the Appraisal and Valuation Manual of the Royal Institution of Chartered Surveyors. Surpluses or deficits arising on the revaluation are dealt with through the revaluation reserve (except that in the event of a permanent diminution of value of an investment property below its cost, the deficit is written off in the profit and loss account). Depreciation is provided only on these investment properties which are leasehold and where the unexpired lease term is less than 20 years. Although this policy is in accordance with the FRSSE (Jan 2008), it is a departure from the general requirements of the Companies Act 2006 for all tangible assets to be depreciated. In the opinion of the directors, compliance with the standard is necessary for the financial statements to give a true and fair view. Depreciation or amortisation is only one of many factors reflected in the annual valuation and the amount of this which might otherwise have been charged cannot be separately identified or quantified.

Fixed Assets

All fixed assets are initially recorded at cost.

Financial Instruments

Financial liabilities and equity instruments are classified according to the substance of the contractual arrangements entered into. An equity instrument is any contract that evidences a residual interest in the assets of the entity after deducting all of its financial liabilities.
