



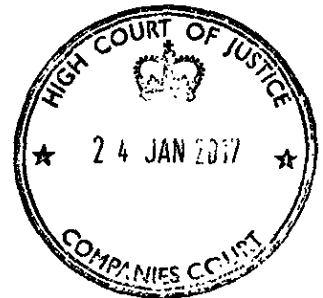

**UPON** the Claimants' claim for restoration of Akzo Nobel Investments Limited (Company Number 00716444) (the "Company") issued by the Central London County Court on 30 September 2016 with Claim no. 1519/2016;

**AND UPON** the Claimants' application to the Central London County Court by notice dated 13 December 2016 for the appointment of Stephen Roland BROWNE and Christopher Richard Frederick DAY (the "New Liquidators") as new liquidators of the Company following its restoration to the Register of Companies (the "Application");
