#### 1. ACCOUNTING POLICIES

The principal accounting policies which are adopted in the preparation of the Company's Accounts are as follows:

## a. Accounting for Service Charges

The company is responsible for the management of Cleves Court, 16 St Marks Hill, Surbiton, Surrey and collects service charges from lessees in order to fund expenditure incurred in the management of the property.
