- (4) in the event that the Claimant fails to comply with undertaking (C) above the Registrar of Companies be at liberty to commence strike off action in respect of the Company without further notice to the Claimant

(5) the Claimant James Leo Heneghan do pay to the Registrar of Companies his costs of the said Application in the agreed sum of £300-00
