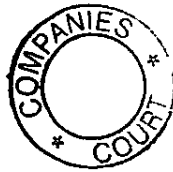

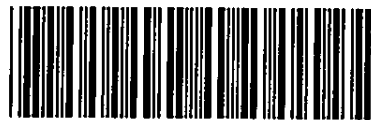

UPON THE APPLICATION by a Claim Form issued on the 24th July 2013 of Mr John McShane the Claimant and a creditor of the above named ABB Building Technologies Limited (hereinafter called "the Company")

AND UPON READING the evidence

AND IT APPEARING that there is no opposition on behalf of Her Majesty in right of Her Duchy of Lancaster to the relief sought by this Claim as appears from the waiver letter from the Solicitor for the Duchy of Lancaster c/o Messrs Farrer & Co dated the 1 October 2013



AND on leave being given to amend the Claim Form to show the correct name of the Company as ABB Building Technologies Limited and re service being dispensed with

AND the Claimant by his solicitors undertaking to

- (A) inform the Registrar of Companies immediately on the conclusion of the proceeding litigation issued against the Company under Claim Number HQ13X01500 or of any appeal therefrom or on the conclusion of the claim against the Company by any

other means referred to in paragraph 17 of the Witness Statement of Jennifer Seavor dated the 23rd July 2013

- (B) unless the said litigation against the Company is completed in the interim, at 6 monthly intervals from the date of the order serve on the Registrar of Companies a full and sufficient Witness Statement setting out what steps have been taken to progress the said litigation against the Company

AND UPON the solicitors for the Claimant and for the Registrar of Companies (the Defendant) both consenting to this Order

IT IS ORDERED THAT

- (1) the name of the above named ABB Building Technologies Limited be restored to the Register of Companies
- (2) the Company do continue in Members' Voluntary Liquidation
- (3) if at the date of registration of this Order with the Registrar of Companies the name of the Company is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the Company to 00756091 Limited
- (4) an Office Copy of the Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the Company is thereupon to be deemed to have continued in existence as if its name had not been struck off

(5) the Registrar of Companies do advertise notice of this Order in his official name
in the "London Gazette"

(6) in the event that the Claimant fails to comply with undertaking (B) above the
Registrar of Companies be at liberty to commence strike off action in respect of
the Company without further notice to the Claimant

(7) the hearing fixed for the 25th October 2013 at 2 00 pm be vacated
