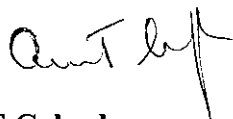

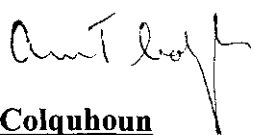
For the year ended 28 February 2006 the Company was entitled to exemption under Section 249AA(1) of the Companies Act 1985.
