

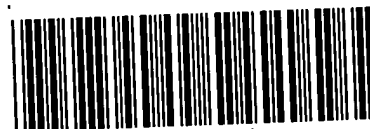

- (6) the office and dispensary equipment and all other moveable items, equipment, fittings and furniture owned by the Chargor and used exclusively in connection with or for the Business and located at the Property save for any computer hardware or software;
- (7) any and all (i) stock within the Property including NHS items processed but not claimed; (ii) branded and generic stock within the Property with more than 3 months to expiry; and (iii) over the counter stock within the Property (including the Chargor's own branded products), in each case held by the Chargor for use in the Business;
- (8) the daily record kept by the Chargor of the cash takings and prescription item numbers of the Business and all other information held by the Chargor which relates exclusively to the Business, including without limitation all dispensing records, the patient medication records relating exclusively to the Business and all records relating to employees of the Business (including any accident report books), but not including any records required by law to be retained by the Chargor; and
- (9) the benefit of:
  - (i) the right to be included in any pharmaceutical list prepared and kept by the Health Board (as defined in the National Health Service (Scotland) Act 1978 pursuant to the National Health Service (Pharmaceutical Services) (Scotland) Regulations 2009 (as amended), and
  - (ii) any and all contracts or agreements for the sale or supply of products or services by the Chargor to nursing homes or residential care homes or to other customers of the Business entered into by the Chargor in the ordinary course of the Business and not other retail pharmacy or business owned or run by the Chargor or the Chargor's group.
