No director who held office on 31 December 2005 had an interest in the company's shares either during the financial year or at 31 December 2005.


Statement of directors' responsibilities


For the year ended 31 December 2005 the company was entitled to exemption under section 249AA(1) of the Companies Act 1985.

5. Related party transactions

The ultimate parent undertaking is Suez SA, a company incorporated in France.

The largest group of which Ebenezer Mears (Plant Hire) Limited is a member and for which group financial statements are drawn up is that headed by Suez SA, whose consolidated financial statements are available from 16 Rue de la Ville L'Eveque, Paris, France. The smallest such group is that headed by SITA Holdings UK Limited, a company registered in England & Wales. The consolidated financial statements of the SITA Holdings UK Limited Group may be obtained from SITA House, Grenfell Road, Maidenhead, Berkshire, SL6 1ES.

In the opinion of the directors, SITA Holdings UK Limited controls the company as a result of controlling 100% of the issued share capital of Ebenezer Mears (Plant Hire) Limited. Suez SA is the ultimate controlling party, being the ultimate controlling party of SITA Holdings UK Limited.
