**1 ACCOUNTING POLICIES**

**Basis of preparing the financial statements and going concern**

The balance sheet is insolvent due to a deficit maintenance reserve. The directors confirmed that the issue will be addressed in the following years by a gradual increase of maintenance contributions levied to the lessees. The accounts are therefore prepared on a going concern basis.

**Accounting convention**

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008).

**Income**

Income represents service charges and premiums receivable from lessees.

**Maintenance reserve**

The maintenance reserve comprises sums set aside to carry forward as a provision against future maintenance costs. Such provision is considered prudent to enable the company to manage the property.

**Profit and loss account**

It is considered that the activities of the company do not give rise to a profit or loss due to its nature of mutual trading. Any excess service charges levied over the current expenditure will be retained in the maintenance reserve.
