The declaration of solvency, sworn by the directors prior to the commencement of the liquidation, showed a debt totalling £100 due from BAE Systems plc The debt has been distributed by assignment to BAE Systems Electronics Limited, as sole shareholder of the Company (see "Distributions" below).

The Company had no known creditors A notice to creditors to prove their claims in the liquidation was advertised in The London Gazette newspaper on 16 December 2013 No creditors were forthcoming as a result of this advertisement

A search of the Index of Proprietors' Names at HM Land Registry revealed eight positive title searches. However, on further investigation, it transpired the eight tiles were actually registered in the name of BAE Systems Electronics Limited, the shareholder of the Company. Therefore, no further action was required

Tax

The Company's tax advisors advised that the Company had dormant corporation tax status Following their appointment, the Joint Liquidators sought and received confirmation from HM Revenue and Customs ("HMRC") that the Company had no outstanding corporation tax returns or liabilities, that it would not raise enquiries into any pre or post liquidation periods and that it had no objection to the liquidators calling a final meeting of members to conclude the liquidation

A similar assurance was sought and received from HMRC in respect of PAYE and VAT matters

Distributions

On 12 May 2014 the Joint Liquidators declared a first and final distribution of the assets of the Company to BAE Systems Electronics Limited, as the sole beneficial shareholder of the Company

The distribution was at the rate of £1 per £1 Ordinary share and was effected by assignment of the debt totalling £100 due to the Company from BAE Systems plc

Joint Liquidators' remuneration and expenses

In the event, the liquidators' remuneration has been paid by another group company and accordingly no detailed analysis is included in this report.
