

1 Accounting convention

2 Profit and loss account

3 Cash flow statement

The directors have taken advantage of the exemption available under FRS 1 of the requirement to prepare a cash flow statement as a consolidated cash flow statement has been presented in the financial statements of the ultimate parent undertaking.

4 Related party transactions

The company has taken advantage of the exemption within FRS 8 not to disclose transactions with other companies where 90% or more of their voting rights are controlled within the group
