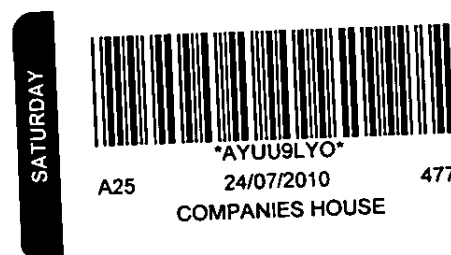

1 Basis of Accounting

The accounts are prepared under the historical cost convention and in accordance with applicable accounting standards The annual accounts are made up 31 December

2 Parent Company

Throughout the year and up until 2 February 2010, the Company was ultimately a wholly owned subsidiary of Cadbury plc (now Cadbury Limited, following re-registration as a private limited company on 4 June 2010)

On 7 September 2009 Kraft Foods, Inc ('Kraft') announced its intention to purchase the entire issued share capital of Cadbury plc On 2 February 2010, Kraft declared its recommended Final Offer wholly unconditional as to acceptances Cadbury plc was delisted from the London and New York Stock Exchanges on 8 March 2010 Kraft became the sole shareholder of Cadbury plc on 2 June 2010

Cadbury plc is also the largest and the smallest group in which the results of the Company are consolidated for the years ending 31 December 2008 and 31 December 2009 Copies of the Group financial statements of Cadbury plc are available from Cadbury House, Sanderson Road, Uxbridge, Middlesex, UB8 1DH

3 Group Accounts

As permitted by the Companies Act 2006, the Company, being a wholly owned subsidiary of a company incorporated in Great Britain, does not prepare accounts

For the year ended 31 December 2009, the Company is entitled to the exemption from audit conferred by subsection (1) of Section 480 of the Companies Act 2006 (the 'Act') and no notice has been deposited under subsection (2) of Section 476 of the Act requiring an audit of its accounts for the financial year
