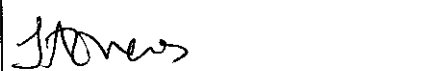

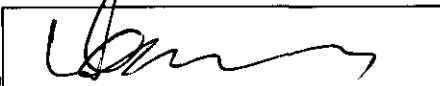

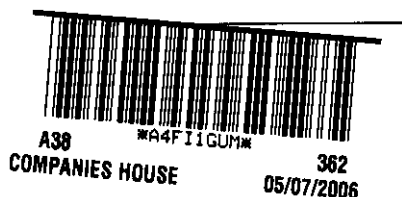

**NOTES**
