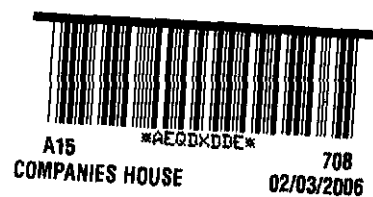

The company was dormant throughout the financial year.

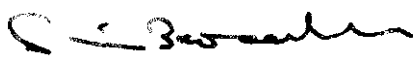
For the year ended 30 September 2005 the company was entitled to exemption under section 249aa(1) of the Companies Act 1985.
