IT IS ORDERED THAT

- 1 The Applicants have permission to make the composite application in respect of each

 - 3 1 3 The Second Applicant be appointed as liquidator in place of the Respondent for the cases listed in Schedule B
 - 3 2 in each bankruptcy referred to in the attached schedules and pursuant to section 298(1) and section 303(2) Insolvency Act 1986 and Rule 7 10B (2) Insolvency Rules 1986
 - 3 2 1 The Respondent be removed from the office of trustee in bankruptcy of the relevant individual, and
 - 3 2 2 The First Applicant be appointed as trustee in bankruptcy in place of the Respondent for the cases referred to in Schedule C,
 - 3 3 in each individual voluntary arrangement referred to in Schedule D, the First Applicant be appointed as supervisor of the individual voluntary arrangement in place of the Respondent pursuant to section 263(5) Insolvency Act 1986 and Rule 7 10B(2) Insolvency Rules 1986
 - 3 4 in each partnership voluntary arrangement referred to in Schedule E, the First Applicant be appointed as supervisor of the partnership voluntary arrangement in place of the Respondent pursuant to Article 4 of the Insolvent Partnerships Order 1994 and section 7(5) and paragraph 39(6) of Schedule A1 of the Insolvency Act 1986 and Rule 7 10B(2) Insolvency Rules 1986
 - 3 5 in the company voluntary arrangement referred to in Schedule F, the Second Applicant be appointed as supervisor of the company voluntary arrangement in place of the Respondent pursuant to section 7(5) and paragraph 39(6) of

Schedule A1 of the Insolvency Act 1986 and Rule 7 10B(2) Insolvency Rules
1986

- 4 Where, in each of the relevant insolvency proceedings set out in the schedules, there is no case number or the proceedings have not yet been issued before a court, the High Court has jurisdiction
- 5 The Applicants shall forthwith serve a copy of this order on
 - a) The Respondent
 - b) The creditors named in the schedules to this order
 - c) The Secretary of State
- 6 That a sealed copy of this Order is lodged with the court having jurisdiction over each case affected by this Order for filing on the court file relating to that case
- 7 Pursuant to Rule 7 10D(4) Insolvency Rules 1986 the costs of this application be apportioned equally and payable as an expense of the insolvency proceedings to which the application relates save that where such apportioned costs would exceed 10% of the value of realised assets in such proceedings those costs shall be apportioned equally and payable as an expense of the remaining insolvency proceedings
- 8 This order was made by the Court of its own initiative without service of the application on any person and without a hearing Any person affected by this order may apply to have it set aside or varied, Any such application must be made no later than 14 days after service of this order on them
- 9 Liberty to apply
