

# REPORT ON ACTIVITIES APRIL 2021 – APRIL 2022 From the Chair

The year has seen war return to Europe and this will have a profound impact not only on this continent but further afield. This will lead to a readjustment of security strategy and capabilities of the UK and allies as we commit to supporting the Ukrainian people's defence of their nation. The war impacts on the scope for international co-operation around peace and disarmament. CCADD has begun to reorientate its programme accordingly adding additional discussions in March and April following Russia's invasion. The future programme will give attention to questions related to European security, direct and indirect human impacts of the Ukraine war and engagement with the Ecumenical and Russian Orthodox faith communities.

The year has also seen the preparation for the Nuclear Non-Proliferation Treaty Review in August 2022 and the first Meeting of State Parties of the Treaty on the Prohibition of Nuclear Weapons. Belligerent rhetoric from the Russian Government regarding its nuclear arsenal has further fuelled the debate on the role that these weapons play in security policy.

The past year has seen the introduction of a Film Circle and a Book Club. The latter enables members to hear from the authors of newly published books.

In July 2021 the Annual Lecture was given jointly by Prof Esther Reed, University of Exeter and Dr Anicée Van Engeland, Cranfield University. Titled 'New technologies and the control of weapons: A Christian perspective', the presenters provided some contrasting

perspectives on the ethics of weapons control from Christian and Islamic ethical viewpoints.

#### HONORARY TREASURER'S REPORT

Year ended 5 April 2022

Following the pattern of many years, the Council's management costs have exceeded income from subscriptions.

Due to active pursuit of new memberships, however, the trend of declining membership has been reversed with annual income from subscriptions increasing for the first time in many years.

The current rate of losses would be manageable within the cash reserves of CCADD for at least 5 years, and the Council is therefore a going concern.

The Management Committee is pursuing continued membership growth and considering measures to reduce management costs so as to achieve a balanced position, and allow pro-active improvement of the website service for members in a more unstable international security situation. External grants are also being sought.
