### **REPORT OF THE COMMITTEE OF MANAGEMENT 2022-2023**

The Committee of Management present their report for the financial year ended 5<sup>th</sup> April 2023. The Committee of Management members serve as Directors of the Company but also act as Trustees of the Charity, the Council on Christian Approaches to Defence and Disarmament Ltd.

### **ACTIVITIES**

The activities of the Council are concerned with the advancement of the Christian ethics particularly as it bears on such questions as the defence and security of nations and the promotion of world peace. The distinctive contribution of CCADD is to provide a meeting place for Christians and others, of widely differing views. CCADD as a corporate entity does not advocate any particular defence or disarmament policy.

### **COMMITTEE OF MANAGEMENT**

In September 2022 Steve Hucklesby gave notice of his intention to stand down as Co-Chair once a new Chair was in place. The Management Committee were very grateful for all the work that he had done and all that he had achieved during his time in the Chair and wished him all success in his new PhD. At the meeting in January 2023, Simon Webb agreed to act as interim Chair and at the March meeting the Committee were delighted to confirm his appointment as the new CCADD Chair.

In June 2022, Keith Suter and Kate Wythe were both co-opted on to the Management Committee and were formally elected on to the Committee at the AGM in September. The Committee was then delighted that Kate Wythe agreed to take on the position of CCADD Honorary Treasurer. The Committee was also grateful for the work done by Simon Webb as Acting Treasurer.

In July 2022, Professor Philip McCormack, Dr Sara Silvestri and Professor Adrian Kendry were also co-opted on to the Committee and were formally elected to the Committee at the AGM in September. The Committee was very grateful for their willingness to serve.

### Year ended 5 April 2023

This year there has been a significant reduction in the amount received from subscriptions. This is a combination of mortality and losing touch with members. As this is currently the main source of income, this drop has had a significant impact on our ongoing viability. However, the return of in person events this year should provide opportunities for raising money through admission charges for non-members.. We also need to focus on a recruitment drive, a more stringent approach to subscription payment amounts and a focus on events where a charge may be made or a donation requested.

It is also necessary to improve access to the bank as there have been occasions where money has had to be paid from an individual's account to cover immediate payment requirements, and this is not an suitable method of running the finances.

These will both be addressed in the coming financial year.
