# NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31ST DECEMBER 1997

#### 1. ACCOUNTING POLICIES

## 1.1 BASIS OF ACCOUNTING

The financial statements have been prepared under the historical cost convention.
