- (1) Any property, books, papers or records to which any of the companies or individuals listed in Schedules A to D (inclusive) of this Order ("the insolvent estates") appear to be entitled including but not limited to all paper records of the insolvent estates within the Respondent's possession or control and all records held in electronic format.
- (2) All books papers and other records in the custody, power or control of the Respondent that relate to the Respondent's administration of the insolvent estates including all paper records and all records held in electronic format to include but not be limited to time records and all emails sent and received by the Respondent in relation to the administration of the insolvent estates and an image of the Respondent's computer equipment, and
- (3) All bank documents including pass books, cheque books, paying-in books, bank statements and all other monies and assets belonging to the insolvent estates
