Directors' report

This directors' report has been prepared in accordance with the provisions in Part 15 of the Companies Act 2006 relating to companies subject to the small companies regime.

The directors present their report and the audited financial statements for the year ended 31 March 2018.

Activities

The principal activities of the company were expanding during the year. It continued to retail cards and gifts, as well as operating the retail gift aid scheme in Mencap shops.

In June 2017, Mencap Limited took over from its parent, Royal Mencap Society, in providing Disclosure Barring Service (DBS) checks for other charities, companies and single applicants, as well as Mencap staff and volunteers.

With effect from 1st April 2018, Mencap Limited has taken over activities related to the organisation of promotional activities from Mencap Promotions Limited, also a subsidiary of Royal Mencap Society.

Review of results and future prospects

The results for the year to 31 March 2018 are set out in the attached financial statements. The company made an operating profit of £75,071 (2017: loss of £21,563). The directors intend to continue with the present activities of the company, including those taken over from Mencap Promotions Limited.

Statement of directors' responsibilities

The directors are responsible for preparing the directors' report and the financial statements in accordance with applicable law and regulations.

Independent auditor's report to the members of Mencap Limited

Opinion

We have audited the financial statements of Mencap Limited for the year ended 31 March 2018 which comprise the profit and loss account, the balance sheet and notes to the financial statements, including a summary of significant accounting policies. The financial reporting framework that has been applied in their preparation is applicable law and United Kingdom Accounting Standards, including Financial Reporting Standard 102 The Financial Reporting Standard applicable in the UK and Republic of Ireland (United Kingdom Generally Accepted Accounting Practice).

This report is made solely to the company's members, as a body, in accordance with Chapter 3 of Part 16 of the Companies Act 2006. 1. Accounting policies

Statutory information

Mencap Limited is a private company, limited by shares, domiciled in England and Wales, registration number 00889191. The registered office is 123 Golden Lane, London EC1Y ORT.

Accounting convention

The accounts have been prepared in accordance with the Financial Reporting Standard for Small Entities effective April 2008 and the provisions of FRS 102 Section 1A – small entities. There were no material departures from that standard.

The principal accounting policies adopted in the preparation of the financial statements are set out below and have remained unchanged from the previous year, and also have been consistently applied within the same accounts.

The financial statements are prepared under the historical cost convention in £ sterling.

Turnover

Turnover arises from the company's principal activity carried out in England, Wales and Northern Ireland. All income is recognised in the profit and loss account when the conditions for income receipt have been met and there is reasonable assurance of income receipt.

Stocks

Stocks, which comprise stationery and goods for resale, are stated at the lower of cost and net realisable value.

Debtors and creditors

Short term debtors are measured at transaction price less any impairment. Short term creditors are measured at transaction price.

Going concern

The financial statements have been prepared on a going concern basis as the company considers that it has adequate resources to continue in operational existence for the foreseeable future.
