Directors' report

This directors' report has been prepared in accordance with the provisions in Part 15 of the Companies Act 2006 relating to companies subject to the small companies' regime.

The directors present their report and the audited financial statements for the year ended 31 March 2023.

Activities

The principal activities of the company were conducting the trading activities of the Mencap group. The company sells cards and gifts, as well as operating the retail gift aid scheme in Mencap shops. The company also provides Disclosure Barring Service (DBS) checks for charities, companies, and single applicants, as well as Royal Mencap Society staff and volunteers.

With effect from 1st April 2018, Mencap Limited has taken over activities related to the organisation of promotional activities from Mencap Promotions Limited, also a subsidiary of Royal Mencap Society.

Review of results and future prospects

The results for the year to 31 March 2023 are set out in the attached financial statements. The company made an operating profit of £152,964 (2022: profit of £210,465). This decrease is due to demand for our Disclosure and Barring Service (DBS) checks returning to a normal level after a post-Covid surge in 2021-22. There was also an increase in Cost of Sales due to higher payroll costs. The decrease in DBS income was partially offset by a small increase in retail income due to our trading no longer being affected by Covid restrictions in 2022-23. The directors intend to continue with the present activities of the company, including those taken over from Mencap Promotions Limited. We expect activity on DBS checks and retail to broadly continue at the 2023 level.

Statement of directors' responsibilities

The directors are responsible for preparing the directors' report and the financial statements in accordance with applicable law and regulations.

Company law requires the directors to prepare financial statements for each financial year in accordance with United Kingdom Generally Accepted Accounting Practice (United Kingdom Accounting Standards) and applicable law.

Under company law the directors must not approve the financial statements unless they are satisfied that they give a true and fair view of the state of affairs of the company and of the profit or loss of the company for that period. In preparing these financial statements, the directors are required to:

- · select suitable accounting policies and then apply them consistently.
- · make judgments and estimates that are reasonable and prudent.
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the company will continue in business.

The directors are responsible for keeping adequate accounting records that are sufficient to show and explain the company's transactions and disclose with reasonable accuracy at any time the financial position of the company and enable them to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

The following statements have been affirmed by each of the directors of the company:

- so far as each director is aware, there is no relevant audit information (that is, information needed by the company's auditors in connection with preparing their report) of which the company's auditors are unaware; and
- each director has taken all the steps that he ought to have taken as a director in order to make himself aware of any relevant audit information and to establish that the company's auditors are aware of that information.

Independent Auditor's Report to the Members of Mencap Limited

Opinion

We have audited the financial statements of Mencap Limited for the year ended 31 March 2023 which comprise the profit and loss account, the balance sheet and notes to the financial statements, including significant accounting policies. The financial reporting framework that has been applied in their preparation is applicable law and United Kingdom Accounting Standards, including Financial Reporting Standard 102 The Financial Reporting Standard applicable in the UK and Republic of Ireland (United Kingdom Generally Accepted Accounting Practice).

In our opinion, the financial statements:

- give a true and fair view of the state of the company's affairs as at 31 March 2023 and of its profit for the year then ended;
- have been properly prepared in accordance with United Kingdom Generally Accepted Accounting Practice;

If we identify such material inconsistencies or apparent material

misstatements, we are required to determine whether this gives rise to a material misstatement in the financial statements themselves. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact.

We have nothing to report in this regard.

In the light of the knowledge and understanding of the company and its environment obtained in the course of the audit, we have not identified material misstatements in directors' report.

We have nothing to report in respect of the following matters in relation to which the Companies Act 2006 requires us to report to you if, in our opinion:

- adequate accounting records have not been kept by the company, or returns adequate for our audit have not been received from branches not visited by us; or
- · the financial statements are not in agreement with the accounting records and returns; or
- certain disclosures of directors' remuneration specified by law are not made; or

Our audit procedures to respond to these risks included enquiries of management about their own identification and assessment of the risks of irregularities, sample testing on the posting of journals, reviewing accounting estimates for biases and reading minutes of meetings of those charged with governance.

Owing to the inherent limitations of an audit, there is an unavoidable risk that we may not have detected some material misstatements in the financial statements, even though we have properly planned and performed our audit in accordance with auditing standards. We are not responsible for preventing non-compliance and cannot be expected to detect non-compliance with all laws and regulations.

These inherent limitations are particularly significant in the case of misstatement resulting from fraud as this may involve sophisticated schemes designed to avoid detection, including deliberate failure to record transactions, collusion or the provision of intentional misrepresentations.

Notes to the accounts

Year ended 31 March 2023

1. Accounting policies

Statutory information

Mencap Limited is a private company, limited by shares, domiciled in England and Wales, registration number 00889191. The registered office is 6 Cyrus Way, Hampton, Peterborough, England, PE7 8HP.

Accounting convention

The accounts have been prepared in accordance with the Financial Reporting Standard for Small Entities effective April 2008 and the provisions of FRS 102 Section 1A – small entities. There were no material departures from that standard.

The principal accounting policies adopted in the preparation of the financial statements are set out below and have remained unchanged from the previous year, and also have been consistently applied within the same accounts.

The financial statements are prepared under the historical cost convention in £ sterling.

During the year, a review was undertaken of the allocation of payroll costs between Mencap Limited and its parent, Royal Mencap Society with the underlying basis being updated. The comparative figures have been updated to reflect this change.

Turnover

Turnover arises from the company's principal activity carried out in England, Wales and Northern Ireland. All income is recognised in the profit and loss account when the conditions for income receipt have been met and there is reasonable assurance of income receipt.

Stocks

Stocks, which comprise stationery and goods for resale, are stated at the lower of cost and net realisable value.

Debtors and creditors

Short term debtors are measured at transaction price less any impairment. Short term creditors are measured at transaction price.

Going concern

The financial statements have been prepared on a going concern basis as the company considers that it has adequate resources to continue in operational existence for the foreseeable future.
