1.—The name of the Company is WEST TRIANGLE RENTALS LIMITED.

2.—The Registered Office of the Company will be situate in England.

- 3.—The objects for which the Company is established are:—
 - (a) To carry on in all their branches the business of renters and hirers of all forms of heating plant, equipment and installations, and as hirers, manufacturers, importers, exporters, distributors and repairers of wholesale and retail dealers in and agents for the sale of plant, equipment, fixtures, fittings, furniture, huts, temporary buildings, caravans, automobiles, aircraft, seacraft, vehicles of all descriptions, furniture, hardware, instruments, apparatus, domestic appliances and articles of household use and hire purchase financiers in connection with any of the foregoing.

- (d) To purchase, take on lease, or otherwise acquire and hold, improve, mortgage, charge, rent, hire, surrender, licence, any freehold, leasehold or other lands, hereditaments, buildings or other property, chattels, and effects and erect, pull down, repair, alter or develop any site or buildings, and adapt the same for the purpose of the Company's business.
- (e) To purchase or otherwise acquire all or any part of the business or assets of any person, firm, or company, carrying on or formed to carry on any business which this Company is authorised to carry on or possessed of property suitable to the purposes of this Company and to pay cash or to issue any shares, stocks, debentures or debenture stock of this Company as the consideration for such purchase or acquisition and to undertake any liabilities or obligations relating to the business or property so purchased or acquired.
 - (f) To apply for, purchase or otherwise acquire any patents, licenses or concessions which may be capable of being dealt with by the Company, or be deemed to benefit the Company and to grant rights thereout.

- (g) To sell, let, license, develop or otherwise deal with the undertaking, or all or any part of the property or assets of the Company, upon such terms as the Company may approve, with power to accept shares, debentures or securities of, or interest in, any other Company.
- (h) To invest and deal with the moneys of the Company in any manner that the Company may think fit.
- (i) To lend money to such persons, upon such terms and/or security and subject to such conditions as may seem desirable.
- (j) To guarantee the payment of any debentures, debenture stock, bonds, mortgages, charges, obligations, interest, dividends, securities, moneys or shares or the performance of contracts or engagements of any other company or person, and to give indemnities and guarantees of all kinds and to enter into partnership or any joint purse arrangement with any person, persons, firm, or Company, having for its objects similar objects to those of this Company or any of them.

PRELIMINARY.

- 1.—The Regulations set out in Table A (Part II) of the First Schedule to the Companies Act 1948 (hereinafter referred to as Table "A") shall except as hereinafter provided apply to the Company and Regulation I of Part 1 of Table A shall apply to the construction of these Articles.
- 2.—Regulations 3 of Part II, and the proviso to 32, 53, 60, 75 and proviso to 79, 84, 88 and 94 of Part I shall not apply to this Company.

SHARES.

3.—Subject to the provisions of Section 58 of the Act any Preference Shares may be issued on the terms that they are, or at the option of the Company are liable to be redeemed.

Art.5

VARIATION OF RIGHTS.

4.—If any such separate general meeting as is referred to in Regulation 4 of Part I of Table "A" shall be adjourned by reason of there being no quorum present and if at the adjourned meeting a quorum shall not be present within half an hour from the time appointed for such adjourned meeting the holders of shares of the class present shall be a quorum.

TRANSMISSION OF SHARES.

5.—Any shares may be transferred by a member to any child or other issue, father, mother, brother, sister, husband or wife of such member, and any share of a deceased member may be transferred to any such relative as aforesaid of the deceased member or to the executors or administrators of any such deceased member. Any share standing in the name of the trustees of the Will of any deceased member, or of a settlement created by a deceased member may be transferred upon any change of Trustees to the Trustees for the time being of such will or settlement or to a person to whom the deceased member would have been entitled to transfer the same during his life. Save as afore aid the Directors may in their absolute discretion and without assigning any reason therefore decline to register any transfer of any share whether or not it is a fully paid share.

SPECIAL CLAUSE

6.—The Holder of any number of the Company's Shares up to and including 100 who dies or, if employed by the Company, leaves the Company's service for any reason whatever agrees on behalf of himself, his Administrators and Assigns to transfer the Shareholding immediately on decease or leaving the Company's service respectively to the Chairman of the Company for the time being or to any person he may in writing appoint and such Holder authorises the Directors of the Company to appoint any one of their Members effectively to make such transfer on behalf of such Holder and the consideration for such transfer shall be the payment to such Holder by the Chairman of the Company or the appointed transferee of the sum of £1 per share transferred.

QUORUM.

7.—No business shall be transacted at any General Meeting unless a Quorum of Members is present at the time when the Meeting proceeds to business; two members present in person shall form a quorum.

DIRECTORS.

- 8.—The number of Directors shall not be more than five
- 9.—Richard Brian Douglas, Richard James Douglas, Mervyn Wilbert Douglas and Joan Marcia Douglas shall be the first Directors of the Company.

POWERS AND DUTIES OF DIRECTORS.

- 10.—A Director may hold any other office or place of profit under the Company (other than the office of Auditor) in conjunction with his office of Director for such period and on such terms (as to remuneration and otherwise) as the Directors may determine.
- 11.—Any Director may act by himself or his firm in a professional capacity for the Company and he or his firm shall be entitled to remuneration for professional services as if he were not a Director provided that nothing herein contained shall authorise a Director or his firm to act as Auditor of the Company.
 - 12.—The Office of Director shall be vacated if the Director:—
 - (a) Ceases to be a Director by virtue of Section 182 of the Act.
 - (b) Becomes bankrupt or makes any arrangement or composition with his creditors generally, or
 - (c) Becomes prohibited from being a Director by reason of any order made under Section 188 of the Act, or
 - (d) Becomes of unsound mind, or
 - (e) Resigns his office by notice in writing to the Company.
- 13.—Subject to the provisions of Section 199 of the Act a Director may contract with and participate in the profits of any contract or arrangement with the Company as if he were not a Director. A Director shall also be capable of voting in respect of such contract or arrangement where he has previously disclosed his interest to the Company. A general disclosure that a Director is interested in transactions with any particular firm or company shall be sufficient disclosure for this purpose.


