



### The Main Subject Matter of this Mortgage

#### 1. The Property and other assets

- (b) the benefit of all rights, licences, guarantees, rent deposits, contracts, deeds, undertakings and warranties relating to the Property,

#### 2. The Debt which is secured on the Property and other assets


