

PARTIES

- (1) MONARCH AIRCRAFT ENGINEERING LIMITED incorporated and registered in England and Wales with company number 00902230 whose registered office is at Prospect House, Prospect Way, London Luton Airport, Luton Bedfordshire, LU2 9NU (the Mortgagor), and
- (2) TRANSCONTINENTAL AVIATION LIMITED incorporated and registered in Bermuda whose registered office is at Canon's Court, 22 Victoria Street, Hamilton, HM12, Bermuda (the Lender).

RECITALS

- (A) The Mortgager is already a party to, and may in future become a party to further, documents with the Lender (and others) under which the Mortgagor is or will become indebted to the Lender (either as principal or as security or in any other manner)
- (B) The Mortgagor is the owner of the Property
- (C) This legal mortgage is entered into to provide security over the Property for all past, present and future obligations of the Mortgagor or the Secured Parties to the Lender of any nature whatsoever

WHEREBY IT IS AGREED as follows

1 DEFINITIONS AND INTERPRETATION

11 Definitions

The definitions and rules of interpretation in this clause apply in this legal mortgage

Barclays Indemnity means a Deed of Indemnity of even date herewith in respect of a Barclays Overdraft Facility between, Inter alia, the Mortgagor and the Lender;

Business Day means a day (other than a Saturday or Sunday) on which banks are open for general business in London,

Charged Property means all the assets, property and undertaking for the time being subject to any Encumbrance created by this legal mortgage. References to the Charged Property shall include references to any part of it,

Costs means all costs, charges, expenses, taxes and liabilities of any kind, including (without limitation) costs and damages in connection with litigation, professional fees, disbursements and any VAT charged on Costs which the Lender or any Receiver or Delegate may charge or incur in relation to this legal mortgage, the Charged Property or breach of any provision of this legal mortgage by the Mortgagor,

Delegate means any person appointed by the Lender or any Receiver pursuant to clause 12 and any person appointed as attorney of the Lender, Receiver or Delegate,

Encumbrance means any mortgage, charge (whether fixed or floating, legal or equitable), pledge, lien, assignment by way of security or other security interest securing any obligation of any person, or any other agreement or arrangement having a similar effect;

Environment means all of the air, water and land, including (without limitation) the air within buildings and other natural or man-made structures above or below ground, ground and surface water, and surface and sub-surface soil,

Environmental Law means all applicable statutes, treaties, regulations, directives or similar measures relating to the pollution or protection of the Environment that affect the Charged Property,

Environmental Licence means any authorisation required by an Environmental Law in respect of any of the Charged Property,

Event of Default means any event described as a Default in the Guarantee and Loan Agreement and any event, whether or not so described entitling the Lender to claim payment under any or all of the Indemnities,

Financing Document means the Guarantee and Loan Agreement and the Indemnities (or if the context so requires, any of them),

Guarantee and Loan Agreement means a Guarantee and Loan Agreement of even date herewith in respect of a loan facility made available in October 2009 and any further agreement entered into at any time by way of addition or supplement to, or replacement or extension of, any such Guarantee and Loan Agreement,

Indemnities means the Barclays Indemnity, the MS Indemnity and the NatWest Indemnity,

Insurance Policies means the insurance policies referred to in clause 3 2,

LPA means the Law of Property Act 1925,

Material Adverse Effect means a material adverse effect on the value to the Lender of the security hereby created,

MS Indemnity means a Deed of Indemnity of even date herewith in respect of a Morgan Stanley Fuel Facility between, inter alia, the Mortgagor and the Lender and any further agreement or indemnity entered into at any time by way of addition or supplement to , or replacement or extension of, any such Indemnity,

NatWest Indemnity means a Deed of Indemnity of even date herewith amending an indemnity in respect of a NatWest overdraft and guarantee facility between, inter alia, the Mortgagor and the Lender and any further agreement or indemnity entered into at any time by way of addition or supplement to , or replacement or extension of, any such Indemnity;

Property means the freehold or leasehold property (whether registered or unregistered) owned by the Mortgagor described in Schedule 1,

Receiver means a receiver and/or manager of any or all of the Charged Property,

Rights means any Encumbrance or other right or benefit whether ansing by set-off, counterclaim, subrogation, indemnity, proof in liquidation or otherwise and whether from contribution or otherwise,

Secured Liabilities means all present and future monies, obligations and liabilities owed by the Mortgagor to the Lender, howsoever ansing and whether actual or contingent, owed jointly or severally; owed as principal or surety or in any other capacity whatsoever, originally owing to the Lender or purchased or otherwise acquired by it, and denominated in sterling or in any other

currency, and including, but not in any way limited to, all liabilities from time to time outstanding under the Guarantee and Loan Agreement, the Indemnities and any guarantee, indemnity or other suretyship undertaking granted by the Mortgagor in respect of liabilities owed to the Lender by all or any of the Secured Parties or any other company,

Secured Parties means Monarch Airlines Leasing Limited of Prospect House, Prospect Way, Luton, Bedfordshire LU2 9NU in respect of the Guarantee and Loan Agreement, Monarch Airlines Limited of Prospect House, Prospect Way, Luton, Bedfordshire LU2 9NU in respect of the Barclays Indemnity and the MS Indemnity; and all of Monarch Airlines Limited, Monarch Holdings Limited and Monarch Travel Group Limited all also of Prospect House, Prospect Way, Luton, Bedfordshire LU2 9NU in respect of the NatWest Indemnity.

Security Period means the period starting on the date of this legal mortgage and ending on the date on which all the Secured Liabilities have been unconditionally and irrevocably paid and discharged in full and no further Secured Liabilities are capable of becoming outstanding under any existing arrangement, and

VAT means value added tax

12 Interpretation

- A reference to a clause or Schedule is to a clause of, or Schedule to, this legal mortgage and references to paragraphs are to paragraphs of the relevant Schedule
- A reference to this legal mortgage (or any specified provision of it) or any other document shall be construed as a reference to this legal mortgage, that provision or that document as in force for the time being and as amended from time to time
- A reference to a person shall include a reference to an individual, firm, company, partnership, corporation, unincorporated body of persons, or any state or any agency of a person
- 1 2 7 A reference to an amendment includes a supplement, variation, novation or reenactment (and amended shall be construed accordingly)
- A reference to assets includes present and future properties, undertakings, revenues, rights and benefits of every description

13 Clawback

If the Lender considers that an amount paid in respect of the Secured Liabilities is capable of being avoided or otherwise set aside on the liquidation or administration of the Mortgagor or any of the Secured Parties, or otherwise, then that amount shall not be considered to have been irrevocably paid for the purposes of this legal mortgage

1 4 Nature of security over real property

A reference in this legal mortgage to a charge or mortgage of or over the Property includes

- 14.1 all buildings and fixtures and fittings (including trade and tenant's fixtures and fittings) and fixed plant and machinery which are situated on or form part of the Property at any time,
- 1 4 2 the proceeds of sale of any part of the Property and any other monies paid or payable in respect of or in connection with the Property,
- the benefit of any covenants for title given, or entered into, by any predecessor in title of the Mortgagor in respect of the Property and any monies paid or payable in respect of those covenants, and
- 1.4.4 all rights under any licence, agreement for sale or agreement for lease in respect of the Property

15 Law of Property (Miscellaneous Provisions) Act 1989

For the purposes of section 2 of the Law of Property (Miscellaneous Provisions) Act 1989, the terms of the Financing Documents and of any side letters between any parties in relation to the Financing Documents are incorporated into this legal mortgage

16 Third party rights

A third party (being any person other than the Mortgagor, the Lender and its permitted successors and assigns, any Receiver and any Delegate) has no right under the Contracts (Rights of Third Parties) Act 1999 to enforce, or to enjoy the benefit of, any term of this legal mortgage

17 Perpetuity period

The perpetuity period applicable to all trusts declared by this legal mortgage shall be 80 years

18 Schedules

2 COVENANT TO PAY

The Mortgagor shall, on demand, pay to the Lender and discharge the Secured Liabilities when they become due.

3 GRANT OF SECURITY

3.1 Legal mortgage and fixed charges

As a continuing security for the payment and discharge of the Secured Liabilities, the Mortgagor, with full title guarantee, charges to the Lender

 - 3 1 2.2 the benefit of all contracts, guarantees, appointments, warranties and other documents to which the Mortgagor is a party or in its favour or of which it has the benefit relating to any letting, development, sale, purchase or the operation or otherwise relating to the Charged Property, including, in each case, but without limitation, the right to demand and receive all monies whatsoever payable to or for its benefit under or ansing from any of them, all remedies provided for in any of them or available at law or in equity in relation to any of them, the right to compel performance of any of them and all other rights, interests and benefits whatsoever accruling to or for its benefit arising from any of them; and
 - 3 1.2 3 all authorisations (statutory or otherwise) held or required in connection with the Mortgagor's business carned on at the Property or the use of any Charged Property, and all rights in connection with them

32 Assignment

As a continuing security for the payment and discharge of the Secured Liabilities, the Mortgagor with full title guarantee assigns to the Lender all its rights in any policies of insurance relating to the Property, including the proceeds of any claims under such policies, provided that nothing in this clause 3.2 shall constitute the Lender as mortgagee in possession.

4 PERFECTION OF SECURITY

4.1 Registration of legal mortgage at the Land Registry

The Mortgagor consents to an application being made by the Lender to the Land Registrar for the following restriction in Form P to be registered against its title to the Property:

"No disposition of the registered estate by the propnetor of the registered estate or by the proprietor of any registered charge, not being a charge registered before the entry of this restriction is to be registered without a written consent signed by the proprietor for the time being of the charge dated 30.12.2013 in favour of Transcontinental Aviation Limited referred to in the charges register."

4.2 Cautions against first registration and notices

If any notice (whether agreed or unilateral) or caution is registered against the Mortgagor's title to the Property, the Mortgagor shall immediately provide the Lender with full particulars of the circumstances relating to such caution or notice. If such caution or notice was registered to protect a purported interest the creation of which is not permitted under this legal mortgage, the Mortgagor shall immediately, and at its own expense, take such steps as the Lender may require to ensure that the caution or notice, as applicable, is withdrawn or cancelled.

5 LIABILITY OF THE MORTGAGOR AND LENDER'S PROTECTIONS

5 1 Liability not discharged

The Mortgagor's liability under this legal mortgage in respect of any of the Secured Liabilities shall not be discharged, prejudiced or affected by

- 5 1 1 any intermediate payment, settlement of account or discharge in whole or in part of the Secured Liabilities, or
- any variation, extension, discharge, compromise, dealing with, exchange or renewal of any right or remedy which the Lender may now or after the date of this legal mortgage have from or against the Mortgagor, any Secured Party or any other person in connection with the Secured Liabilities, or
- 5 1 3 any act or omission by the Lender or any other person in taking up, perfecting or enforcing any Encumbrance, indemnity, or guarantee from or against the Mortgagor, any Secured Party or any other person, or
- 5 1 4 any termination, amendment, variation, novation or supplement of or to any of the Secured Liabilities, or
- any grant of time, indulgence, waiver or concession to the Mortgagor, any Secured Party or any other person; or
- any insolvency, bankruptcy, liquidation, administration, winding-up, incapacity, limitation, disability, the discharge by operation of law, or any change in the constitution, name or style of the Mortgagor, any Secured Party or any other person, or
- any invalidity, illegality, unenforceability, irregularity or frustration of any actual or purported obligation of, or Encumbrance held from, the Mortgagor, any Secured Party or any other person in connection with the Secured Liabilities, or
- any claim or enforcement of payment from the Mortgagor, any Secured Party or any other person, or
- 5 1 9 any other act or omission which, but for this provision, might operate to exonerate or discharge the Mortgagor or otherwise reduce or extinguish its liability under this legal mortgage

52 Immediate recourse

5.3 The Mortgagor waives any right it may have to require the Lender

- 5 3 1 to take any action or obtain judgement in any court against any Secured Party or any other person, or
- 5.3.2 to make or file any claim in a bankruptcy, liquidation, administration or insolvency of any Secured Party or any other person, or
- 5 3 3 to make demand, enforce or seek to enforce any claim, right or remedy against any Secured party or any other person,

before taking steps to enforce any of its rights or remedies under this legal mortgage

54 Non-competition

- The Mortgagor warrants to the Lender that it has not taken or received, and shall not take, exercise or receive the benefit of any Rights from or against any Secured Party, its liquidator, administrator, co-guarantor or any other person in connection with any liability of, or payment by, the Mortgagor under this legal mortgage but
 - 5 5 1 If any of the Rights is taken, exercised or received by the Mortgagor, those Rights and all monies at any time received or held in respect of those Rights shall be held by the Mortgagor on trust for the Lender for application in or towards the discharge of the Secured Liabilities under this legal mortgage, and
 - on demand by the Lender, the Mortgagor shall promptly transfer, assign or pay to the Lender all Rights and all monies from time to time held on trust by the Mortgagor under this clause 5.5

6 REPRESENTATIONS AND WARRANTIES

The Mortgagor represents and warrants to the Lender in the terms set out in Schedule 2 on each day during the Security Period

7 COVENANTS

The Mortgagor covenants with the Lender in the terms set out in Schedule 3

8 POWERS OF THE LENDER

The Lender shall have the powers set out in Schedule 4

9 ENFORCEMENT

9 1 When security becomes enforceable

The security constituted by this legal mortgage shall be immediately enforceable and the power of sale and other powers given by section 101 of the LPA (as varied or extended by this legal mortgage) shall be immediately exercisable at any time after either an Event of Default or following a demand made by the Lender for payment of any of the Secured Liabilities

9.2 When statutory powers arise

Section 103 of the LPA shall not apply to this legal mortgage and the statutory power of sale and other powers given by section 101 of the LPA (as varied or extended by this legal mortgage) shall, as between the Lender and a purchaser, arise on the execution of this legal mortgage and be

exercisable at any time after such execution, but the Lender shall not exercise such power of sale until the security constituted by this legal mortgage has become enforceable under clause 9 1

93 Enforcement of security

After the security constituted by this legal mortgage has become enforceable, the Lender may in its absolute discretion enforce all or any part of that security at the times, in the manner and on the terms it thinks fit and may take possession of, and hold or dispose of, all or any part of the Charged Property

9.4 Redemption of prior Encumbrances

At any time after the security constituted by this legal mortgage has become enforceable, or after any powers conferred by any Encumbrance having priority to this legal mortgage shall have become exercisable, the Lender may

- 9 4 1 redeem such or any other prior Encumbrance, or procure its transfer to itself, and
- 9 4 2 settle any account of that encumbrancer

The settlement of any such account shall be conclusive and binding on the Mortgagor All monies paid by the Lender to an encumbrancer in settlement of such an account shall, as from its payment by the Lender, be due from the Mortgagor to the Lender and shall be secured as part of the Secured Liabilities

9.5 Extension of statutory powers of leasing

The statutory powers of leasing and accepting surrenders are extended so as to authorise the Lender, any Receiver and any Delegate, at any time after the security constituted by this legal mortgage has become enforceable, whether in its own name or in that of the Mortgagor, to make any lease or agreement for lease, accept surrenders of leases or grant any option of the whole or any part of the Property with whatever rights relating to other parts of it, containing whatever covenants on the part of the Mortgagor, generally on such terms and conditions (including the payment of money to a lessee or tenant on a surrender) and whether or not at a premium as the Lender, Receiver or Delegate thinks fit without the need to comply with any of the restrictions imposed by sections 99 and 100 of the LPA

96 Privileges

Each Receiver and the Lender is entitled to all the rights, powers, privileges and immunities conferred by the LPA on mortgagees and receivers

97 No liability as mortgagee in possession

Neither the Lender, any Receiver nor any Delegate shall be liable to account as mortgagee in possession in respect of all or any of the Charged Property, nor shall any of them be liable for any loss on realisation of, or for any neglect or default of any nature in connection with, all or any of the Charged Property for which a mortgagee in possession might be liable as such

98 Relinquishing possession

If the Lender, any Receiver or any Delegate enters into or takes possession of the Charged Property, it or he may at any time relinquish possession

10 Receivers

10.1 Appointment and removal of a Receiver

At any time after the security constituted by this legal mortgage has become enforceable or at the request of the Mortgagor, the Lender may, without further notice

- 10 1 1 appoint under seal or in writing, by a duly authorised officer of the Lender, any one or more person or persons to be a receiver or a receiver and manager, of all or any part of the Charged Property, and
- 10 1 2 (subject to section 45 of the Insolvency Act 1986) from time to time, under seal or in writing, by a duly authorised officer of the Lender, remove any person appointed to be Receiver and may, in a similar manner, appoint another in his place

Where more than one person is appointed Receiver, they shall have power to act separately (unless the appointment by the Lender specifies to the contrary)

10.2 Power of appointment additional to statutory powers

The power to appoint a Receiver conferred by this legal mortgage shall be in addition to all statutory and other powers of the Lender under the Insolvency Act 1986, the LPA or otherwise, and shall be exercisable without the restrictions contained in sections 103 and 109 of the LPA

10.3 Power of appointment exercisable despite prior appointments

The power to appoint a Receiver (whether conferred by this legal mortgage or by statute) shall be, and remain, exercisable by the Lender despite any prior appointment in respect of all or any part of the Charged Property

10.4 Remuneration of a Receiver

The Lender may fix the remuneration of any Receiver appointed by it without the restrictions contained in section 109 of the LPA and the remuneration of the Receiver shall be a debt secured by this legal mortgage which shall be due and payable immediately upon its being paid by the Lender

11 POWERS AND CAPACITY OF A RECEIVER

11.1 Powers of a Receiver

11.2 Scope of Receiver's powers

Neither the Lender nor any Receiver shall be in any way liable or responsible to the Mortgagor for any loss or liability arising from any act, default, omission or misconduct on the part of any Delegate.

13 APPLICATION OF PROCEEDS

13.1 Order of application

All monies received by the Lender, a Receiver or a Delegate (other than sums received pursuant to any Insurance Policy) pursuant to this legal mortgage after the security constituted by this legal mortgage has become enforceable, shall (subject to the claims of any person having prior rights and by way of variation of the LPA) be applied

- 13 1 1 first in paying all costs, charges and expenses of, and incidental to, the appointment of any Receiver and the exercise of his powers and all outgoings paid by him,
- 13.1.2 second in paying the remuneration of any Receiver (as agreed between the Receiver and the Lender),
- 13.1.3. third in or towards discharge of the Secured Liabilities in such order and manner as the Lender determines, and
- 13 1 4 finally in paying any surplus to the Mortgagor or any other person entitled to it

132 Appropriation

Neither the Lender, any Receiver nor any Delegate shall be bound (whether by virtue of section 109(8) of the LPA, which is varied accordingly, or otherwise) to pay or appropriate any receipt or payment first towards interest rather than principal or otherwise in any particular order between any of the Secured Liabilities

13.3 Suspense account

All monies received by the Lender or a Receiver or a Delegate under this legal mortgage (other than sums received pursuant to any Insurance Policy which are not going to be applied in or towards discharge of the Secured Liabilities) may, at the discretion of the Lender, Receiver or Delegate, be credited to any suspense or securities realised account and shall bear interest at such rate, if any, as may be agreed in writing between the Lender, Receiver or Delegate and the Mortgagor, and may be held in such account for so long as the Lender, Receiver or Delegate thinks fit

14 PROTECTION OF THIRD PARTIES

14.1 Protection of third parties

No purchaser, mortgagee or other person dealing with the Lender or any Receiver or Delegate shall be concerned

- 14.1.1 to enquire whether any of the Secured Liabilities have become due or payable, or remain unpaid or undischarged, or whether the power the Lender or a Receiver or Delegate is purporting to exercise has become exercisable, or
- 14.1.2 to see to the application of any money paid to the Lender or any Receiver or Delegate

14.2 Conclusive discharge to purchasers

The receipt of the Lender or any Receiver or Delegate shall be a conclusive discharge to a purchaser and, in making any sale or other disposal of any of the Charged Property or in making any acquisition in the exercise of their respective powers, the Lender, every Receiver and every Delegate may do so for such consideration, in such manner and on such terms as it or he thinks fit

15 COSTS AND INDEMNITY

15 1 Costs

The Mortgagor shall pay to, or reimburse, the Lender and any Receiver on demand, on a full indemnity basis, all Costs incurred by the Lender, any Receiver or Delegate in relation to

- 15 1 1 this legal mortgage or the Charged Property,
- 15 1 2 taking, holding, protecting, perfecting, preserving or enforcing (or attempting to do so) any of the Lender's, Receiver's or Delegate's rights under this legal mortgage, and
- 15 1 3 suing for, or recovering, any of the Secured Liabilities,

(including, without limitation, the Costs of any proceedings in relation to this legal mortgage or the Secured Liabilities), together with interest from day to day until full discharge (whether before or after judgment, liquidation, winding-up or administration of the Mortgagor) at the interest rate which is 3% above the Base Rate from time to time of The Royal Bank of Scotland PLC. In the case of any Costs, such interest shall accrue and be payable as from the date on which the relevant Costs arose, without the need for any demand for payment being made.

15.2 Indemnity

The Lender, any Receiver and any Delegate, and their respective employees and agents, shall be indemnified on a full indemnity basis out of the Charged Property in respect of all actions, liabilities and Costs incurred or suffered in or as a result of

- the exercise, or purported exercise, of any of the powers, authorities or discretions vested in them under this legal mortgage,
- any matter or thing done, or omitted to be done, in relation to the Charged Property under those powers, or
- 15 2 3 any default or delay by the Mortgagor in performing any of its obligations under this legal mortgage

16 POWER OF ATTORNEY

16.1 Appointment of attorneys

By way of security, the Mortgagor irrevocably appoints the Lender, every Receiver and every Delegate separately to be the attorney of the Mortgagor and, in its name, on its behalf and as its act and deed, to execute any documents and do any acts and things which

- 16.1.1 the Mortgagor is required to execute and do under this legal mortgage, and
- 16 1 2 any attorney may deem proper or desirable in exercising any of the powers, authorities and discretions conferred by this legal mortgage or by law on the Lender, any Receiver or any Delegate

16.2 Ratification of acts of attorneys

The Mortgagor ratifies and confirms, and agrees to ratify and confirm, anything which any of its attorneys may do in the proper and lawful exercise or purported exercise of all or any of the powers, authorities and discretions referred to in clause 16.1

17 RELEASE

Subject to clause 19 3, on the expiry of the Security Period (but not otherwise), the Lender shall, at the request and cost of the Mortgagor, take whatever action is necessary to release the Charged Property from the security constituted by this legal mortgage

18 ASSIGNMENT AND TRANSFER

18 1 Assignment by the Lender

At any time, without the consent of the Mortgagor, the Lender may assign or transfer the whole or any part of the Lender's rights and/or obligations under this legal mortgage to any person. The Lender may disclose such information about the Mortgagor, the Charged Property and this legal mortgage as the Lender considers appropriate to any actual or proposed assignee or transferee.

18.2 Assignment by the Mortgagor

19.2 Continuing security

This legal mortgage shall remain in full force and effect as a continuing security for the Secured Liabilities, despite any settlement of account, or intermediate payment, or other matter or thing, unless and until the Lender discharges this legal mortgage in writing

19 3 Discharge conditional

Any release, discharge or settlement between the Mortgagor and the Lender shall be deemed conditional on no payment or security received by the Lender in respect of the Secured Liabilities being avoided, reduced or ordered to be refunded pursuant to any law relating to insolvency, bankruptcy, winding-up, administration, receivership or otherwise. Despite any such release, discharge or settlement.

- 19 3 1 the Lender or its nominee may retain this legal mortgage and the security created by or pursuant to it, including all certificates and documents relating to the whole or any part of the Charged Property, for such period as the Lender deems necessary to provide the Lender with security against any such avoidance, reduction or order for refund, and
- 19 3 2 the Lender may recover the value or amount of such security or payment from the Mortgagor subsequently as if such release, discharge or settlement had not occurred

19 5 Rights cumulative

The rights and powers of the Lender conferred by this legal mortgage are cumulative, may be exercised as often as the Lender considers appropriate, and are in addition to its rights and powers under the general law

196 Waivers

Any waiver or variation of any right by the Lender (whether arising under this legal mortgage or under the general law) shall only be effective if it is in writing and signed by the Lender and applies only in the circumstances for which it was given, and shall not prevent the Lender from subsequently relying on the relevant provision

19 7 Further exercise of rights

No act or course of conduct or negotiation by or on behalf of the Lender shall, in any way, preclude the Lender from exercising any right or power under this legal mortgage or constitute a suspension or variation of any such right or power

198 Delay

No delay or failure to exercise any right or power under this legal mortgage shall operate as a waiver

199 Single or partial exercise

No single or partial exercise of any right under this legal mortgage shall prevent any other or further exercise of that or any other right

19 10 Consolidation

The restriction on the right of consolidation contained in section 93 of the LPA shall not apply to this legal mortgage

19 11 Partial invalidity

The invalidity, unenforceability or illegality of any provision (or part of a provision) of this legal mortgage under the laws of any jurisdiction shall not affect the validity, enforceability or legality of the other provisions

19 12 Counterparts

This legal mortgage may be executed and delivered in any number of counterparts, each of which is an original and which together have the same effect as if each party had signed the same document

20 NOTICES

20 1 Service

Any notice or other communication given under this legal mortgage shall be in writing and shall be served by delivering it personally (including by courier) or by fax to the address or fax number and for the attention of the relevant party as set out in Schedule 6 or such other address or fax number as may be notified in writing from time to time by the relevant party to the other party

20 2 Receipt

Receipt of any notice, given under clause 20 1 above, shall be deemed to have taken place

- 20 2 1 If delivered personally (including by couner), at the time of actual delivery,
- 20 2 2 in the case of a fax, with a confirmed receipt of transmission from the receiving machine, when transmitted.

provided that if deemed receipt would otherwise

 (a) occur before 9 00 am on a Business Day, the notice shall be deemed to have been received at 9 00 am on that day, or (b) occur after 5 00 pm on a Business Day or on a day which is not a Business Day, the notice shall be deemed to have been received at 9 00 am on the next Business Day

20 3 Proof of service

20 4 E-mail invalid

Notice given under this legal mortgage shall not be validly served if sent by e-mail

21 GOVERNING LAW AND JURISDICTION

This legal mortgage and any dispute or claim ansing out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with the law of England and Wales

- (a) all deeds and documents of title relating to the Charged Property which are in the possession or control of the Mortgagor (If these are not within the possession and/or control of the Mortgagor, the Mortgagor undertakes to obtain possession of all such deeds and documents of title), and
- (b) all Insurance Policies

7 Notices to be given by the Mortgagor

The Mortgagor shall within five days of the execution of this legal mortgage give notice to the relevant insurers of the assignment pursuant to clause 3.2 of the Mortgagor's rights and interest in and under the Insurance Policies and procure that each addressee of such notice promptly provides an acknowledgement of that notice to the Lender

8 Further assurance

The Mortgagor, at its own cost, shall prepare and execute such further legal or other mortgages, charges or transfers (containing a power of sale and such other provisions as the Lender may reasonably require) in favour of the Lender as the Lender, in its absolute discretion, requires from time to time over all or any part of the Charged Property and give all notices, orders and directions which the Lender may require, in its absolute discretion, for perfecting, protecting or facilitating the realisation of its security over the Charged Property

9 Authorisations

The Mortgagor shall obtain all consents and authorisations necessary (and do all that is needed to maintain them in full force and effect) under any law or regulation of its jurisdiction of incorporation to enable it to perform its obligations under this legal mortgage and to ensure the legality, validity, enforceability and admissibility in evidence of this legal mortgage in its jurisdiction of incorporation

Property covenants Part 2

1 Repair and maintenance

2 No alterations

- (b) carry out or permit or suffer to be carned out on the Property any development as defined in each of the Town and Country Planning Act 1990 and the Planning Act 2008 or change or permit or suffer to be changed the use of the Property

4 Insurance

- 4.1 The Mortgagor shall insure and keep insured (or where, in the case of any leasehold property, insurance is the responsibility of the landlord under the terms of the lease, either procure that the landlord insures and keeps insured or, if and to the extent that the landlord does not do so, itself insure and keep insured) the Charged Property against
 - (a) loss or damage by fire or terronst acts,
 - (b) other risks, penis and contingencies that would be insured against by reasonably prudent persons carrying on the same class of business as the Mortgagor, and
 - (c) any other risk, perils and contingencies as the Lender may reasonably require

Any such insurance must be with an insurance company or underwriters and on such terms as are reasonably acceptable to the Lender and must be for not less than the replacement value of the Charged Property (meaning in the case of any premises on the Property, the total cost of entirely rebuilding, reinstating or replacing the premises in the event of their being destroyed, together with architects', surveyors', engineers' and other professional fees and charges for demolition and reinstatement)

- 4.2 The Mortgagor shall, if requested by the Lender, produce to the Lender the policy, certificate or cover note relating to any such insurance required by paragraph 4.1 of this Part 3 of Schedule 4 (or where, in the case of any leasehold property, such insurance is effected by the landlord, such evidence of insurance as the Mortgagor is entitled to obtain from the landlord under the terms of the relevant lease)
- The Mortgagor shall, if requested by the Lender, procure that a note of the Lender's interest is endorsed upon or that the Lender is named as co-insured with the Mortgagor on each Insurance Policy maintained by it or any person on its behalf in accordance with paragraph 4.1 of this Part 3 of Schedule 3 and that the terms of each such Insurance Policy require the insurer not to invalidate the policy as against the Lender by reason of the act or default of any other joint or named insured and not to cancel it without giving at least 30 days' prior written notice to the Lender

5 Insurance premiums

The Mortgagor

 shall promptly pay all premiums in respect of each insurance Policy and do all other things necessary to keep such policy in full force and effect, and (b) shall (if the Lender so requires) produce to the Lender the receipts for all premiums and other payments necessary for effecting and keeping up the insurance Policies (or where, in the case of leasehold property, insurance is effected by the landlord, such evidence of the payment of premiums as the Mortgagor is entitled to obtain from the landlord under the terms of the relevant lease)

6 No invalidation of insurance

The Mortgagor shall not do or omit to do or permit to be done or omitted any thing that may invalidate or otherwise prejudice the Insurance Policies

7 Insurance Policies' proceeds

All monies payable under any of the Insurance Policies at any time (whether or not the security constituted by this legal mortgage has become enforceable) shall

- (a) immediately be paid to the Lender;
- (b) If they are not paid directly to the Lender by the insurers, be held by the Mortgagor as trustee of the same for the benefit of the Lender (and the Mortgagor shall account for them to the Lender), and
- (c) at the option of the Lender, be applied in making good or recouping expenditure in respect of the loss or damage for which such monies are received or in or towards discharge or reduction of the Secured Liabilities or be applied in making good or recouping expenditure in respect of the loss or damage for which such monies are received or, after the security constituted by this legal mortgage has become enforceable and if the Lender so directs, in or towards discharge or reduction of the Secured Liabilities

8 Leases and licences affecting the Property

The Mortgagor shall not, without the prior written consent of the Lender which consent, in the case of paragraph 8 1(d), is not to be unreasonably withheld or delayed in circumstances in which the Mortgagor may not unreasonably withhold or delay its consent:

- (a) grant, or agree to grant, any licence or tenancy affecting the whole or any part of the Property, or exercise the statutory powers of leasing (or agreeing to lease) or of accepting (or agreeing to accept) surrenders under sections 99 or 100 of the LPA, or
- (b) in any other way dispose of (or agree to dispose of), accept the surrender of (or agree to accept the surrender of), surrender (or agree to surrender) or create any legal or equitable estate or interest in the whole or any part of the Property, or
- (c) let any person into occupation of or share occupation of the whole or any part of the Property, or
- (d) grant any consent or licence under any lease or licence affecting the Property

9 No restrictive obligations

The Mortgagor shall not, without the prior written consent of the Lender, enter into any onerous or restrictive obligations affecting the whole or any part of the Property or create or permit to arise any overriding interest, easement or right whatsoever in or over the whole or any part of the Property

10 Proprietary rights

The Mortgagor shall procure that no person shall become entitled to assert any propnetary or other like right or interest over the whole or any part of the Property, without the prior written consent of the Lender

11 Compliance with and enforcement of covenants

The Mortgagor shall

- (a) observe and perform all covenants, stipulations and conditions to which the Property, or the use of it, is or may be subject and (if the Lender so requires) produce to the Lender evidence sufficient to satisfy the Lender that those covenants, stipulations and conditions have been observed and performed, and
- (b) diligently enforce all covenants, stipulations and conditions benefiting the Property and shall not (and shall not agree to) waive, release or vary any of the same

12 Notices or claims relating to the Property

12 1 The Mortgagor shall

- (a) give full particulars to the Lender of any notice, order, direction, designation, resolution, application, requirement or proposal given or made by any public or local body or authority (a Notice) that specifically applies to the Property, or to the locality in which it is situated, within seven days after becoming aware of the relevant Notice, and
- (b) (if the Lender so requires) immediately, and at the cost of the Mortgagor, take all reasonable and necessary steps to comply with any Notice, and make, or join with the Lender in making, such objections or representations in respect of any such Notice as the Lender may desire
- 12.2 The Mortgagor shall give full particulars to the Lender of any claim, notice or other communication served on it in respect of any modification, suspension or revocation of any Environmental Licence or any alleged breach of any Environmental Law, in each case relating to the Property

13 Payment of rent and outgoings

The Mortgagor shall in relation to the Property

- (a) where the Property, or part of it, is held under a lease, duly and punctually pay all rents due from time to time, and
- (b) pay (or procure payment of the same) when due all charges, rates, taxes, duties, assessments and other outgoings relating to or imposed upon the Property or on its occupier

14 Rent reviews

The Mortgagor shall not, without the prior written consent of the Lender, if the Property is leasehold, agree to any change in the rent payable under the lease in excess of the open market rental value and shall only agree to any upwards rent review in accordance with the terms of the lease

15 Environment

The Mortgagor shall-

- (a) properly discharge in all material respects all duties of care and responsibility placed upon it by Environmental Law and comply in all material respects with the terms of any Environmental Licences,
- (b) observe and perform in all material respects all the requirements of Environmental Law; and
- (c) apply for and obtain all Environmental Licences

16 Conduct of business on Property

The Mortgagor shall carry on its trade and business on those parts (if any) of the Property as are used for the purposes of trade or business in accordance with the standards of good management from time to time current in such trade or business

17 Inspection

The Mortgagor shall permit the Lender and any Receiver and any person appointed by either of them to enter on and inspect the Property on reasonable pnor notice

18 VAT option to tax

The Mortgagor shall not, without the pnor written consent of the Lender

- (a) exercise any VAT option to tax in relation to the Property, or
- (b) revoke any VAT option to tax exercised prior to and disclosed to the Lender in writing prior to the date of this legal mortgage

SCHEDULE 4

Powers of the Lender

1 Power to remedy

- 1 1 The Lender shall be entitled (but shall not be obliged) to remedy a breach at any time by the Mortgagor of any of its obligations contained in this legal mortgage. The Mortgagor irrevocably authorises the Lender and its agents to do all such things as are necessary or desirable for that purpose. Any monies expended by the Lender in remedying a breach by the Mortgagor of any of its obligations contained in this legal mortgage shall be reimbursed by the Mortgagor to the Lender on a full indemnity basis and shall carry interest in accordance with clause 15.1.
- 1 2 In remedying any breach in accordance with paragraph 1.1 of this Schedule 4, the Lender, its agents and their respective officers, agents and employees shall be entitled to enter onto the Property and to take any action as the Lender may reasonably consider necessary or desirable including, without limitation, carrying out any repairs, other works or development

2 Exercise of rights

The rights of the Lender under paragraph 1 of this Schedule 4 are without prejudice to any other rights of the Lender under this legal mortgage. The exercise of those rights shall not make the Lender liable to account as a mortgagee in possession.

3 Lender has Receiver's powers

To the extent permitted by law, any right, power or discretion conferred by this legal mortgage on a Receiver may, after the security constituted by this legal mortgage has become enforceable, be exercised by the Lender in relation to any of the Charged Property whether or not it has taken possession of any Charged Property and without first appointing a Receiver or notwithstanding the appointment of a Receiver

4 Conversion of currency

For the purpose of, or pending, the discharge of any of the Secured Liabilities, the Lender may convert any monies received, recovered or realised by the Lender under this legal mortgage (including the proceeds of any previous conversion under this paragraph 4) from their existing currencies of denomination into such other currencies of denomination as the Lender may think fit Any such conversion shall be effected at the Royal Bank of Scotland prevailing spot selling rate of exchange for such other currency against the existing currency Each reference in this paragraph 4 to a currency extends to funds of that currency and, for the avoidance of doubt, funds of one currency may be converted into different funds of the same currency

5 New accounts

- 5.1 If the Lender receives, or is deemed to have received, notice of any subsequent Encumbrance or other interest, affecting all or part of the Charged Property, the Lender may open a new account for the Mortgagor in the Lender's books. Without prejudice to the Lender's right to combine accounts, no money paid to the credit of the Mortgagor in any such new account shall be appropriated towards, or have the effect of discharging, any part of the Secured Liabilities.
- 5 2 If the Lender does not open a new account immediately on receipt of the notice or deemed notice referred to in paragraph 5 1 of this Schedule 4, then, unless the Lender gives express written notice to the contrary to the Mortgagor, all payments made by the Mortgagor to the

Lender shall be treated as having been credited to a new account of the Mortgagor and not as having been applied in reduction of the Secured Liabilities, as from the time of receipt or deemed receipt of the relevant notice by the Lender

6 Indulgence

The Lender may, at its discretion, grant time or other indulgence or make any other arrangement, variation or release with any person that is not party to this legal mortgage (whether or not such person is jointly liable with the Mortgagor) in respect of any of the Secured Liabilities or of any other security for them without prejudice either to this legal mortgage or to the liability of the Mortgagor for the Secured Liabilities

SCHEDULE 5

Powers of a Receiver

1 Power to repair and develop the Property

A Receiver may undertake or complete any works of repair, alteration, building or development on the Property and may apply for and maintain any planning permission, development consent, building regulation approval or any other permission, consent or licence to carry out any of the same

2 Power to grant or accept surrenders of leases

A Receiver may grant, or accept surrenders of, any leases or tenancies affecting the Property and may grant any other interest or right over the Property on such terms and subject to such conditions as he thinks fit

3 Power to employ personnel and advisers

A Receiver may, for the purposes of this Schedule 5, provide services and employ, or engage, such managers, officers, servants, contractors, workmen, agents, other personnel and professional advisers on such salaries, for such periods and on such other terms as he thinks fit A Receiver may discharge any such person or any such person appointed by the Mortgagor

4 Power to make and revoke VAT options to tax

A Receiver may exercise or revoke any VAT option to tax as he thinks fit

5 Power to charge for remuneration

A Receiver may charge and receive such sum by way of remuneration (in addition to all costs, charges and expenses incurred by him) as the Lender may prescribe or agree with him

6 Power to realise Charged Property

A Receiver may collect and get in the Charged Property or any part of it in respect of which he is appointed and make such demands and take such proceedings as may seem expedient for that purpose, and take possession of the Charged Property with like rights

7 Power to manage or reconstruct the Mortgagor's business

A Receiver may carry on, manage, develop, reconstruct, amalgamate or diversify or concur in carrying on, managing, developing, reconstructing, amalgamating or diversifying the business of the Mortgagor carried out at the Property

8 Power to dispose of Charged Property

A Receiver may grant options and licences over all or any part of the Charged Property, sell or concur in selling, assign or concur in assigning, lease or concur in leasing and accept or concur in accepting surrenders of leases of, all or any of the Charged Property in respect of which he is appointed for such consideration and, in such manner (including, without limitation, by public auction or private sale) and generally on such terms and conditions as he thinks fit. A Receiver may promote, or concur in promoting, a company to purchase the Charged Property to be disposed of by him

9 Power to sever fixtures and fittings

A Receiver may sever and sell separately any fixtures or fittings from the Property without the consent of the Mortgagor

10 Power to give valid receipts

A Receiver may give valid receipts for all monies and execute all assurances and things which may be proper or desirable for realising any of the Charged Property

11 Power to make settlements

A Receiver may make any arrangement, settlement or compromise between the Mortgagor and any other person as he thinks fit

12 Power to bring proceedings

A Receiver may bring, prosecute, enforce, defend and abandon all actions, suits and proceedings in relation to any of the Charged Property as he thinks fit

13 Power to insure

A Receiver may, if he thinks fit, but without prejudice to the indemnity in clause 15.2, effect with any insurer any policy of insurance either in lieu or satisfaction of, or in addition to, the insurance required to be maintained by the Mortgagor under this legal mortgage

14 Powers under LPA

A Receiver may exercise all powers provided for in the LPA in the same way as if he had been duly appointed under that act and exercise all powers provided for an administrative receiver in Schedule 1 of the Insolvency Act 1986

15 Power to borrow

A Receiver may, for any of the purposes authorised by this Schedule 5, raise money by borrowing from the Lender (or from any other person) on the security of all or any of the Charged Property in respect of which he is appointed on such terms as he thinks fit (including, if the Lender consents, terms under which such security ranks in priority to this legal mortgage)

16 Power to redeem prior Encumbrances

A Receiver may redeem any prior Encumbrance and settle and pass the accounts to which the Encumbrance relates. Any accounts so settled and passed shall be conclusive and binding on the Mortgagor, and the monies so paid shall be deemed to be an expense properly incurred by the Receiver.

17 Power of absolute owner

A Receiver may do all such acts and things as an absolute owner could do in the ownership and management of the Charged Property or any part of it

18 Incidental powers

A Receiver may do all such other acts and things as he may consider incidental or conducive to any of the matters or powers in this Schedule 5, or which he lawfully may or can do as agent for the Mortgagor
