"Farm Out Agreement" means the farm out agreement dated 16 April 2010 between Ophir, the Chargor, Ophir Energy plc, Ophir Tanzania (Block 3) Limited and Ophir Tanzania (Block 4) Limited.

"PSA" means production sharing agreement in relation to Block 1 between the Government of the United Republic of Tanzania, the Tanzania Petroleum Development Corporation and Ophir dated 29 October 2005 (as amended from time to time)

"PSA Parties" means the parties (in their roles as Contractor Parties as named in the PSA) to the PSA from time to time.
