**Memorandum of Association**

(As amended on 6<sup>th</sup> December, 1969)

OF

RAILWAY COMPANY LIMITED**

1 The name of the Company (hereinafter called "the Company") is "SEVERN VALLEY RAILWAY COMPANY LIMITED"

2 The registered office of the Company will be situate in England

3 The objects for which the Company is established are -

(1) (a) To preserve, retain and restore the standard gauge railway extending from Bridgnorth to Kidderminster via Bewdley in the Counties of Salop and Worcester or any part or parts thereof and for such purpose to purchase, take upon lease, or otherwise acquire from the British Railways Board the said railway or part or parts thereof and the lands, works, buildings, track, stock, machinery and rights relating thereto

(b) To purchase or otherwise acquire any lands, docks, canals, waterways, warehouses, wharves, railway tracks, stations, bridges, tunnels, points, signals, signal boxes, level crossings, locomotives, rolling stock, wires, cables, ducts conduits and all ancillary equipment, installations, buildings or machinery, and to construct and equip the same, to work, equip and maintain railways and to obtain any statutory powers and authority or any Provisional Orders of the Board of Trade or any orders consents or other authorization of any government officer, government department local and municipal authority, and any other person for that purpose or for any purpose within the objects of the Company, to apply for parliamentary powers that may appear conducive to the interests of the Company, to enter into contracts for the carriage of passengers, goods and livestock by any means, and purchase take on lease or otherwise acquire and work any railway wharf, pier, dock, buildings or works capable of being advantageously used in connection with the business of the Company in connection with any of the objects aforesaid, to carry on the business of a railway company, railway contractors, engineers, manufacturers of machinery and railway wagons and coach builders, to acquire concessions or licences for the establishment and working To erect, construct, lay down, enlarge, alter and maintain any roads, railways, tramways, buildings, works, plant and machinery necessary or convenient for the Company's business, and to contribute to or subsidise the erection, construction and maintenance of any of the above

(c) To purchase, take on lease or in exchange, hire or otherwise acquire any real or personal property and any rights or privileges which the Company may think necessary or convenient for the promotion of its objects, and to construct, maintain and alter any buildings or erections necessary or convenient for the work of the Company

- (d) To sell, let, mortgage, dispose of or turn to account all or any of the property or assets of the Company as may be thought expedient with a view to the promotion of its objects
  - (e) To print reproduce and publish books, treatises, photographs and diagrams, time-tables and other publications of all descriptions relating to such railways or other means of transport, and to form, manage and maintain a museum or permanent display thereof
  - (f) To undertake and execute any charitable trusts which may lawfully be undertaken by the Association and may be conducive to its objects
  - (g) To build, purchase, charter, hire or otherwise acquire maintain repair and use steam or other engines or locomotives, rolling stock, machinery and property of every kind necessary or useful for the purpose of carrying on the business of the Company
  - (h) To carry and convey passengers goods livestock and all kinds of merchandise by the said railway or other railways or tramways and to hire and trade with passenger or freight vehicles belonging to or in the possession of the company and generally to carry on business as carriers of passengers and goods in all its branches
  - (i) To acquire, build work and use factories of all kinds, furnaces, mills, foundries, hotels, hostels, camping grounds, cafes and places of refreshment, licensed or otherwise and to carry out waterworks, schemes of lighting drainage and other works for improving or developing or enhancing the property of the Company
  - (j) To promote and make application to the Ministry of Transport and to any other competent authority for all or any Order or Orders Amendment Order or Orders licences consents or permissions necessary or expedient for the acquisition and operation of the said railway or other tramways or railways or otherwise for the furtherance of the before-mentioned objects of the Company or any of them
  - (k) To make bye-laws and regulations governing the use by persons of and the conduct of persons upon all such lands, buildings, works, plant and machinery within the control or supervision of the Company as aforesaid and to obtain any statutory or other consents for this purpose
- (2) To carry on any businesses similar to the businesses above-mentioned or which may be conveniently or advantageously carried on or combined with them
  - (3) Subject to the provisions of Section 14 of the Companies Act, 1948, to purchase or sell, take or let on lease, take or give in exchange or on hire, or otherwise acquire, hold or dispose of any estate or interest in lands, buildings, easements, concessions, machinery, plant, stock in trade, goodwill, trade marks, patents, copyright or licences, or any other real or personal property or any right, privilege, estate or interest
  - (4) To sell, lease, let on hire, improve, manage, develop, mortgage, dispose of, turn to account or otherwise deal with all or any of the property and rights and undertakings of the Company for such consideration as the Company may think fit
  - (5) To erect, build, construct, alter, improve, enlarge, maintain or work any railways, roads, wharves, stores, buildings, shops, factories, works, plant or machinery necessary for the Company's business
  - (6) To borrow or raise money for the purposes of the Company and for that purpose to mortgage or otherwise charge the whole or any part of the Company's undertaking, property and assets
  - (7) To pay out of the funds of the Company all expenses of, or incident to, the formation, registration and advertising of the Company

- (8) To apply for and take out, purchase or otherwise acquire any patents, patent rights, inventions, or secret processes which may be useful for the Company's objects, and to grant licences to use the same
- (9) To establish or promote any company for the purpose of acquiring all or any of the property, rights and liabilities of the Company or for any other purpose which may seem directly or indirectly calculated to benefit the Company
- (10) To acquire and undertake the whole or any part of the assets and/or liabilities of any person, firm, or company carrying on any business of a nature similar to that which this Company is authorised to carry on
- (11) To amalgamate with any company having objects similar to those of this Company
- (12) To subscribe or guarantee money for any charitable, benevolent, educational or social object, or for any exhibition or for any public, general, or useful object which the Directors may think desirable or advantageous to the Company
- (13) To establish and support, or to aid in the establishment and support of, any club, institution or organisation calculated to benefit persons employed by the Company or having dealings with the Company
- (14) To invest the moneys of the Company not immediately required in or upon such securities and in such manner as the Directors may from time to time determine

Provided that -

- (i) In case the Company shall take or hold any property which may be subject to any trusts, the Company shall only deal with or invest the same in such manner as allowed by law, having regard to such trusts
  - (ii) The Company shall not support with its funds any object, or endeavour to impose or procure to be observed by its members or others any regulation restriction or condition which if an object of the Company would make it a Trade Union
- (15) The income and property of the Company derived from any source whatsoever shall be applied solely towards the promotion of the objects of the Company as set forth in this Memorandum of Association and no part thereof shall be paid transferred or declared directly or indirectly by way of dividend bonus or otherwise by way of profit to the Members. Provided that nothing contained herein shall prevent payment in good faith of reasonable and proper remuneration to any officer or servant or Member of the Company as provided in the Memorandum and Articles of Association
- (16) To do all such other things as are incidental or the Company may think conducive to the attainment of the above objects or any of them

#### 4 The liability of the Members is limited

5 Every Member of the Company undertakes to contribute to the assets of the Company, in the event of its being wound up during the time that he is a Member, or within one year afterwards, for payment of the debts and liabilities of the Company contracted before the time at which he ceases to be a Member, and of the costs, charges and expenses of winding up the same, and for the adjustment of the rights of the contributories amongst themselves, such amount as may be required not exceeding One Pound

OF

**SEVERN VALLEY  
RAILWAY COMPANY LIMITED**

GENERAL

1 In the Articles, unless the context requires otherwise the words standing in the first column of the Table next hereinafter contained shall bear the meaning set opposite to them respectively in the second column thereof -

The United Kingdom	Great Britain and Northern Ireland

Words importing the singular number only shall include the plural number, and vice versa, words importing the masculine gender only shall include the feminine gender, and words importing persons shall include corporations

Unless the context otherwise requires, other words or expressions contained in these Articles bear the same meaning as in the Companies Act 2006 as in force on the date when these Articles become binding on the Company

2 The Subscribers to the Memorandum of Association and such other persons as the Directors shall admit to membership shall be Members of the Company

3 Any person who shall complete an application to become a Member and who shall subscribe to the Company such annual sum as the Company in General Meeting shall from time to time prescribe shall on such payment become qualified to be a Member of the Company

4 Any Member of the Company who shall desire to retire shall signify such desire in writing to the Secretary and thereupon the name of such Member shall be removed from the list of members and he or she shall be deemed to have retired Any Member who fails to pay his annual subscription shall be removed from the list of members after a period of three months from the end of the month in which the subscription falls due for payment

5 No right or privilege for any Member shall be in any way transferable or transmissible and all such rights and privileges shall cease upon the Member ceasing to be such whether by death retirement or otherwise

6 The name of any Member who, in the opinion of the Directors, is or has been guilty of conduct detrimental to the interests of the Company may be removed from the list of members In the case of a Life Member a partial refund of subscription may be made at the discretion of the Directors

#### GENERAL MEETINGS

7 The Company shall in each year hold a General Meeting as its Annual General Meeting in addition to any other meetings in that year, and shall specify the Meeting as such in the notices calling it, and not more than fifteen months shall elapse between the date of one Annual General Meeting of the Company and that of the next The Annual General Meeting shall be held at such time and place as the Directors shall determine

8 All General Meetings other than Annual General Meetings shall be called Extraordinary General Meetings

9 The Directors may, whenever they think fit, convene an Extraordinary General Meeting, and Extraordinary General Meetings shall also be convened on the requisition of Members representing not less than five per cent of the total voting rights of all Members entitled to vote at General Meetings, or, in default, may be convened by such requisitionists, as provided by of the Act If at any time there are not within the United Kingdom sufficient Directors capable of acting to form a quorum, any Director, or any two Members of the Company may convene an Extraordinary General Meeting in the same manner as nearly as possible as that in which Meetings may be convened by the Directors

#### NOTICE OF GENERAL MEETINGS

10 General Meetings shall be called by twenty-one clear days' notice in writing at the least The notice shall specify the place, the day and the hour of the Meeting, and the general nature of the business to be dealt with at the Meeting, and, in the manner required by the Act, that a Member may be represented by not more than one proxy The notice shall be given in manner hereinafter mentioned, or in such other manner, if any, as may be prescribed by the Company in General Meeting, to such persons as are, under the provisions of the Articles, entitled to receive such notices from the Company

11 The accidental omission to give notice of a Meeting to, or the non-receipt of notice of a Meeting by, any Member shall not invalidate the proceedings of that Meeting

## PROCEEDINGS AT GENERAL MEETINGS

12 All business shall be deemed special that is transacted at an Annual General Meeting, with the exception of the consideration of the accounts, balance sheets, and the reports of the Directors and Auditors, the election of Directors in the place of those retiring, the approval of subscription rates, and the appointment of, and the fixing of the remuneration of, the Auditors, and all business shall also be deemed special that is transacted at an Extraordinary General Meeting

13 No business shall be transacted at any General Meeting unless a quorum of Members is present at the time when the Meeting proceeds to business, save as herein otherwise provided, five members personally present shall be a quorum

14 If within half an hour from the time appointed for the Meeting, a quorum is not present, the Meeting, if convened upon the requisition of Members, shall be dissolved, in any other case it shall be held on the same day in the next week, at the same time and place, or on such other day and at such other time and place as the Directors may determine, and if at this Meeting a quorum is not present within half an hour from the time appointed for the Meeting, the Members present shall be a quorum

15 The Chairman, if any, of the Board of Directors, shall preside as Chairman at every General Meeting of the Company, or if there is no such Chairman, or if he shall not be present within fifteen minutes after the time appointed for the holding of the Meeting, or is unwilling to act, the Directors present shall elect one of their number to be Chairman of the Meeting

16 If at any Meeting no Director is willing to act as Chairman, or if no Director is present within fifteen minutes after the time appointed for holding the Meeting, the Members present shall choose one of their number to be Chairman of the Meeting

17 The Chairman may, with the consent of any Meeting at which a quorum is present (and shall if so directed by the Meeting) adjourn the Meeting from time to time and from place to place, but no business shall be transacted at any adjourned Meeting other than the business left unfinished at the Meeting from which the adjournment took place. When a Meeting is adjourned for thirty days or more, notice of the adjourned Meeting shall be given as in the case of an original Meeting. Save as aforesaid it shall not be necessary to give any notice of an adjournment or of the business to be transacted at an adjourned Meeting

18 At every General Meeting, a resolution put to the vote of the Meeting shall be decided on a show of hands, and a declaration by the Chairman of the Meeting that a resolution has been carried, or carried unanimously, or by a particular majority, or lost, shall not be challenged by any Member of the Company, and an entry of the result of the vote in the book containing the minutes of proceedings of the Company shall be conclusive evidence of the fact without proof of the number or proportion of the votes recorded in favour of or against such resolution, but nothing in this Clause shall apply if a poll is demanded in accordance with the provisions of Clause 17 of the Articles

19 A poll, either before or on the declaration of the result of a vote by show of hands, may be demanded -

- (a) By the Chairman, or
- (b) By at least three Members present in person or by proxy, or
- (c) By any Member or Members present in person or by proxy and representing not less than one-tenth of the total voting rights of all the Members having the right to vote at the Meeting

The demand for a poll may be withdrawn

20 A poll demanded on the election of a Chairman or on a question of adjournment shall be taken forthwith, and a poll demanded on any other question shall be taken at such time as the Chairman of the Meeting directs, and any business other than that upon which a poll has been demanded may be proceeded with pending the taking of the poll. The result of the poll shall be deemed to be the resolution of the Meeting at which the poll was demanded



21 In the case of an equality of votes, whether on a show of hands or on a poll, the Chairman of the Meeting at which the show of hands takes place, or at which the poll is demanded, shall be entitled to a second or casting vote

22 Subject to the provisions of the Act, a resolution in writing, signed by all the Members for the time being entitled to receive notice of and to attend and vote at General Meetings (or being corporations, by their duly authorised representatives) shall be as valid and effective as if the same had been passed at a General Meeting of the Company duly convened and held

## VOTES OF MEMBERS

23 Every Member shall have one vote

24 A Member of unsound mind, or in respect of whom an order has been made by any Court having jurisdiction in matters concerning mental disorder, may vote, whether on a show of hands or on a poll, by a person or persons authorised in that behalf appointed by that Court, and such person or persons may, on a poll, vote by proxy

25 No Member shall be entitled to vote at any General Meeting unless all moneys presently payable by him to the Company have been paid

26 Any Member of the Company may appoint any one person (whether or not such person is a Member of the Company) to attend any General Meeting of the Company as his proxy, but no Member shall be represented by more than one proxy at the same Meeting, the instrument appointing a proxy shall be deemed to confer authority to demand or join in demanding a poll, and the proxy shall have the same right to vote on a poll as the Member appointing him, but shall not be entitled to speak at the Meeting, or to vote on a show of hands

27 The instrument appointing a proxy shall be in writing under the hand of the appointor, or of his attorney duly authorised in writing, or if the appointor is a corporation, either under seal or under the hand of an officer or attorney duly authorised

28 The instrument appointing a proxy and the power of attorney or other authority, if any, under which it is signed, or a notarially certified copy of that power or authority, shall be deposited at the registered office of the Company, or at such other place within the United Kingdom as is specified for that purpose in the notice convening the meeting, not less than forty-eight hours before the time for holding the Meeting or adjourned Meeting at which the person named in the instrument proposes to vote, or, in the case of a poll, not less than twenty-four hours before the time appointed for the taking of the poll, and in default the instrument of proxy shall not be treated as valid

29 An instrument appointing a proxy shall state the name and address of the Member appointing the proxy, and identify the person appointed to be that Member's proxy and the General Meeting in relation to which that person is appointed. Unless the instrument indicates otherwise, it must be treated as allowing the person appointed under it as a proxy discretion as to how to vote on any ancillary or procedural resolutions put to the Meeting, and as appointing that person as a proxy in relation to any adjournment of the Meeting to which it relates as well as the Meeting itself

30 The Company may require instruments appointing a proxy to be delivered in a particular form, and may specify different forms for different purposes. Instruments may specify how the proxy appointed under them is to vote (or that the proxy is to abstain from voting) on one or more resolutions

31 An appointment under an instrument of proxy may be revoked by delivering to the Company a notice in writing given by or on behalf of the person by whom or on whose behalf the instrument was given. Such revocation is effective only if delivered before the commencement of the Meeting or adjourned Meeting to which it relates. A vote given in accordance with the terms of an instrument of proxy shall be valid notwithstanding the previous death or mental incapacity of the principal, provided that no intimation in writing of such death or mental incapacity shall have been received by the Company at its registered office before the commencement of the Meeting or adjourned Meeting at which the proxy is used

32 An Ordinary Resolution to be proposed at a General Meeting may be amended by Ordinary Resolution if notice of the proposed amendment is given to the Company in writing by a person entitled to vote at the Meeting at which it is proposed not less than forty-eight hours before the Meeting is to take place (or such later time as the Chairman of the Meeting may determine), and if the proposed amendment does not, in the reasonable opinion of the Chairman of the Meeting, materially alter the scope of the resolution. A Special Resolution to be proposed at a General Meeting may be amended by Ordinary Resolution if the Chairman of the Meeting proposes the amendment at the Meeting at which the resolution is to be proposed, and if the amendment does not go beyond what is necessary to correct a grammatical or other non-substantive error in the resolution. If the Chairman of the Meeting, acting in good faith, wrongly decides that an amendment is out of order, the Chairman's error does not invalidate the vote on that resolution.

#### CORPORATIONS ACTING BY REPRESENTATIVES AT MEETINGS

33 Any Corporation which is a Member of the Company may by resolution of its directors or other governing body authorise such person as it thinks fit to act as its representative at any Meeting of the Company, and the person so authorised shall be entitled to exercise the same powers on behalf of the corporation which he represents as that corporation could exercise if it were an individual Member of the Company.

#### DIRECTORS

34 The maximum number of Directors shall be nine.

35 A Director shall not be entitled to remuneration in respect of his office, or to reimbursement of expenses incurred in connection with attending Meetings of the Directors or Committees of the Directors or General Meetings of the Company.

#### POWERS AND DUTIES OF DIRECTORS

36 The business of the Company shall be managed by the Directors, who may pay all expenses incurred in promoting and registering the Company, and may exercise all such powers of the Company as are not, by the Act or by the Articles, required to be exercised by the Company in General Meeting, subject nevertheless to the provisions of the Act or the Articles, and to such regulations, not being inconsistent with the aforesaid provisions, as may be prescribed by the Company in General Meeting, but no regulation made by the Company in General Meeting shall invalidate any prior act of the Directors which would have been valid if that regulation had not been made.

37 The Directors may from time to time, and at any time, by power of attorney, appoint any company, firm, or person, or body of persons, whether nominated directly or indirectly by the Directors, to be the Attorney or Attorneys of the Company for such purposes, and with such powers, authorities and discretions (not exceeding those vested in or exercisable by the Directors under the Articles), and for such period and subject to such conditions as they may think fit, and any such powers of attorney may contain such provisions for the protection and convenience of persons dealing with any such Attorney as the Directors may think fit, and the Directors may also authorise any such Attorney to delegate all or any of the powers, authorities and discretions vested in him.

38 [a] A Director who is in any way, whether directly or indirectly, interested in a contract or proposed contract with the Company shall declare the nature of his interest at a meeting of the Directors in accordance with the Act

[b] A Director shall not vote in respect of any contract or arrangement in which he is interested, and if he does his vote shall not be counted, nor shall he be counted in the quorum present at the meeting, but neither of these prohibitions shall apply to any contract with or arrangement involving Severn Valley Railway (Holdings) Limited or Severn Valley Railway Association and these prohibitions may at any time be suspended or relaxed to any extent, and either generally or in respect of any particular contract or arrangement, by the Company in General Meeting

[c] Notwithstanding anything contained in the foregoing provisions of this Article, the Directors may exercise the voting powers conferred by the shares in any other company held or owned by the Company, or exercisable by them as directors of such other company, in such manner in all respects as they think fit (including the exercise thereof in favour of any resolution appointing themselves or any of them directors, managers or other officers of such company), and any Director of the Company may vote in favour of the exercise of such voting rights in manner aforesaid, notwithstanding that he may be, or about to be, appointed a director, manager or other officer of such other company, and as such is or may become interested in the exercise of such voting rights in manner aforesaid

39 Subject to the Articles, the Directors may make any rule which they think fit about how they take decisions, and about how such rules are to be recorded or communicated to Directors

40 The Directors shall cause minutes to be made and retained in books provided for the purpose -

- (a) Of all appointments of officers made by the Directors,
- (b) Of the names of the Directors present at each Meeting of the Directors and of any Committee of the Directors, and
- (c) Of all resolutions and proceedings at all Meetings of the Company, of the Directors, and of Committees of Directors

#### DISQUALIFICATION OF DIRECTORS

41 The office of Director shall be vacated if the Director -

- (a) Without the consent of the Company in General Meeting, holds any other office of profit under the Company, or
- (b) Becomes bankrupt, or makes any arrangement or composition with his creditors generally, or
- (c) Becomes prohibited from being a Director by reason of any order made under the Company Directors Disqualification Act 1986, or
- (d) Becomes physically or mentally incapable of acting as a Director, and is likely to remain so for more than three months in the written opinion of a registered medical practitioner who is treating him, or is subject to a court order which wholly or partly prevents him from personally exercising any powers or rights which he would otherwise have, or
- (e) Is convicted of an indictable offence, or
- (f) Gives notice in writing to the Company that he resigns the office of Director, or

- (g) Shall for more than six months have been absent without permission of the Directors from Meetings of the Directors held during that period

#### ROTATION OF DIRECTORS

42 At the first Annual General Meeting of the Company, all the Directors shall retire from office, and at the Annual General Meeting in every subsequent year one-third of the Directors for the time being, or if their number is not three or a multiple of three, then the number nearest one-third, shall retire from office

43 The Directors to retire in every year shall be those who have been longest in office since their last election, but as between persons who became Directors on the same day, those to retire shall, unless they otherwise agree among themselves, be determined by lot

44 The Company, at the Meeting at which a Director retires in the manner aforesaid, may fill the vacated office by electing a person thereto, and a retiring Director shall be eligible for re-election, and if the vacated office is not filled as aforesaid, the retiring Director shall, if offering himself for re-election, be deemed to have been re-elected, unless at such meeting it is expressly resolved not to fill such vacated office or unless a resolution for the re-election of such Director shall have been put to the Meeting and lost

45 No person other than a Director retiring at the Meeting shall, unless recommended by the Directors, be eligible for election to the office of Director at any General Meeting unless, not less than thirty-five nor more than fifty-six days before the date appointed for the Meeting, there shall have been left at the registered office of the Company notice in writing, signed by a Member duly qualified to attend and vote at the Meeting for which such notice is given, of his intention to propose such person for election, and also notice in writing signed by that person of his willingness to be elected

46 The Company may from time to time by Ordinary Resolution increase or reduce the number of Directors, and may also determine in what rotation the increased or reduced number is to go out of office

47 The Directors shall have the power at any time, and from time to time, to appoint any person to be a Director, either to fill a casual vacancy or as an addition to the existing Directors, but so that the total number of Directors shall not at any time exceed the number fixed in accordance with these Articles Any Director so appointed shall hold office only until the next following Annual General Meeting, and shall then be eligible for re-election, but shall not be taken into account in determining the Directors who are to retire by rotation at each Meeting

48 The Company may by Ordinary Resolution, of which special notice has been given in accordance with the Act, remove any Director before the expiration of his period of office, notwithstanding anything in these Articles or in any agreement between the Company and such Director Such removal shall be without prejudice to any claim such Director may have for damages for breach of any contract of service between him and the Company

49 Without prejudice to the powers of the Directors under Clause 47 of the Articles, the Company may, by Ordinary Resolution in General Meeting, appoint any person to be a Director, either to fill a casual vacancy, or as an additional Director, or in place of a Director removed from office under the provisions of Clause 48 of the Articles A person appointed in place of a Director so removed or to fill such a vacancy shall be subject to retirement at the same time as if he had become a Director on the day on which the Director in whose place he is appointed was last elected a Director

## PROCEEDINGS OF DIRECTORS

50 The Directors may meet together for the dispatch of business, adjourn, and otherwise regulate their Meetings, as they think fit. Questions arising at any Meeting shall be decided by a majority of votes. In the case of an equality of votes, the Chairman shall have a second or casting vote. A Director may, and the Secretary on the requisition of a Director shall, at any time summon a Meeting of the Directors. It shall not be necessary to give notice of a Meeting of the Directors to any Director for the time being absent from the United Kingdom.

51 The quorum necessary for the transaction of the business of the Directors may be fixed by the Directors, and unless so fixed shall be three.

52 The continuing Directors may act notwithstanding any vacancy in their body, but if and so long as their number is reduced below the number fixed by or pursuant to the Articles of the Company as the necessary quorum of Directors, the continuing Directors or Director may act for the purpose of increasing the number of Directors to that number, or of summoning a General Meeting of the Company, but for no other purpose.

53 The Directors may elect a Chairman of their Meetings, and determine the period for which he is to hold office, but if no such Chairman is elected, or if at any Meeting the Chairman is not present within five minutes after the time appointed for holding the same, the Directors present may choose one of their number to be Chairman of the Meeting.

54 The Directors may delegate any of their powers to Committees, consisting of such Member or Members of their body and such other Members of the Company as they think fit, any Committee so formed shall in the exercise of the powers so delegated conform to any regulations that may be imposed on it by the Directors.

55 Committees to which the Directors delegate any of their powers must follow procedures which are based, as far as they are applicable, on those provisions of the Articles which govern the taking of decisions by Directors. The Directors may make rules of procedure for Committees, which prevail over rules derived from the Articles if they are not consistent with them.

56 All acts done by any Meeting of the Directors, or of a Committee of Directors, or by any person acting as a Director, shall, notwithstanding that it be afterwards discovered that there was some defect in the appointment of any such Director or person acting as aforesaid, or that they or any of them were disqualified, be as valid as if every such person had been duly appointed and was qualified to be a Director.

57 A resolution in writing, signed by all the Directors for the time being entitled to receive notice of a Meeting of the Directors, shall be as valid and effectual as if it had been passed at a Meeting of the Directors duly convened and held.

## SECRETARY

58 The Directors shall appoint a Secretary of the Company, and may appoint one or more deputy or assistant Secretaries, for such term, at such remuneration and upon such conditions as they may think fit, and any Secretary or deputy or assistant Secretary so appointed may be removed by the Directors.

59 Anything required or authorised to be done, or any notice required or authorised to be given, under the provisions of the Articles, by or to the Secretary may, if the office is vacant or there is for any reason no Secretary capable of acting, be done or given by or to any deputy or assistant Secretary, or if there is no assistant or deputy Secretary capable of acting, by or to any officer of the Company, authorised generally or specially in that behalf by the Directors.

60 A provision of the Act, or of the Articles, requiring or authorising anything to be done by or to a Director and the Secretary shall not be satisfied by its being done by or to the same person acting both as Director and as, or in place of, the Secretary.

## SEAL

61 The Directors shall provide for the safe custody of the Common Seal of the Company, which shall only be used by the authority of the Directors or of a Committee of the Directors authorised by the Directors in that behalf, and every instrument to which the Seal shall be affixed shall be signed by two Directors and shall be countersigned by the Secretary

## ACCOUNTS

62 Except as provided by law or authorised by the Directors or an Ordinary Resolution of the Company, no person is entitled to inspect any of the Company's accounting or other records or documents merely by virtue of being a Member

63 The Directors must lay before the Company in General Meeting copies of its annual accounts and reports

64 A copy of every Balance Sheet, including every document required by law to be annexed thereto, which is to be laid before the Company in General Meeting, together with a copy of the Auditor's Report, shall, not less than twenty-one clear days before the date of the Meeting, be sent to every Member of, and every holder of Debentures of, the Company, provided that the provisions of this Clause shall not require a copy of those documents to be sent to any person of whose address the Company is not aware or to more than one of the joint holders of any Debentures

## AUDIT

65 Auditors shall be appointed and their duties regulated in accordance with the Act

## NOTICES

66 A notice may be given by the Company to any Member either personally or by sending the notice by post to him or to his registered address, in electronic form, or by means of a website. If he has no registered address within the United Kingdom, the notice may be sent to the address, if any, within the United Kingdom supplied by him to the Company for the giving of notice to him. Where a notice is sent by post, service of the notice shall be deemed to be effected by properly addressing, prepaying and posting a letter containing the notice, and to have been effected in the case of a notice of a Meeting at the expiration of seventy-two hours after the letter containing the notice is posted, and in any other case at the time at which the letter would be delivered in the ordinary course of post

67 Notice of every General Meeting shall be given in any manner hereinbefore authorised to every Member of the Company, except those Members who (having no registered address within the United Kingdom) have not supplied to the Company an address within the United Kingdom for the giving of notices to them, and such notice shall also be so given to the Auditor for the time being of the Company, but no other person shall be entitled to receive notices of General Meetings

68 Subject to the Articles, anything sent or supplied by or to the Company under the Articles may be sent or supplied in any way in which the Act provides for documents or information which are authorised or required by any provision of the Act to be sent or supplied by or to the Company. Subject to the Articles, any notice or document to be sent or supplied to a Director in connection with the taking of decisions by Directors may also be sent or supplied by the means by which that Director has asked to be sent or supplied with such notices or documents for the time being. A Director may agree with the Company that notices or documents sent to him in a particular way are to be deemed to have been received within a specified time of their being sent, and for the specified time to be less than forty-eight hours

## WINDING UP

69 If the Company is wound up and any surplus assets remain after the satisfaction of all its debts and liabilities, the same shall not be paid to or distributed among the Members of the Company but shall be given or transferred to some other institution or institutions having objects similar to the objects of the Company, such institution or institutions to be determined by the Members of the Company at or before the time of dissolution and, if and so far as effect cannot be given to such provision, then to some charitable object
