

3 Progress of the Liquidations

I can advise that it was necessary to convert the above mentioned liquidations from
members' voluntary liquidation to creditors' voluntary liquidation on 8 May 2013 following
the identification of a group VAT liability totalling £1,397,576.25

The Companies' have been dormant for a number of years prior to my appointment and the
information provided to me did not indicate their being part of a VAT group.

The VAT Group liability was incurred by the Companies' parent, MSGUK, which is also in
creditors' voluntary liquidation

Claims have been entered in the liquidations from HM Revenue & Customs in respect of the
group VAT liability. No other creditors have come forward to prove their debt against the
Companies

4 Payments to the Unsecured Creditors

Following the receipt of the above mentioned dividends from MSGUK, I have paid the following dividends to the only creditor of each company, being HM Revenue & Customs in respect of the Group VAT liability referred to above.
