**THIS SECURITY ACCESSION DEED** is made on 11 September 2014

**BETWEEN:**

- (1) The entities listed in Schedule 1 (*Additional Chargors*) as acceding companies (the "Additional Chargors" and each an "Additional Chargor")
- (2) Boing Midco Limited, a company incorporated in England & Wales with registered number 9077982 (the "Parent"); and
- (3) U S Bank Trustees Limited as security agent for the Secured Parties (the "Security Agent")

**RECITAL:**

This deed is supplemental to a debenture dated 10 July 2014 between the Original Chargors named therein and the Security Agent, as previously supplemented and amended by earlier Security Accession Deeds (if any) (the "**Debenture**") and to any related Mortgage

**NOW THIS DEED WITNESSES** as follows:

**1 INTERPRETATION**

**1.1 Definitions**

Terms defined in the Debenture and any Mortgage have the same meaning when used in this deed

**1.2 Construction**

Clause 1.1 (*Definitions*), 1.2 (*Terms defined in the Intercreditor Agreement*) and 1.3 (*Construction*) of the Debenture will be deemed to be set out in full in this deed, but as if references in those clauses to, as applicable, the Debenture or any Mortgage were references to this deed.

**2. ACCESSION OF ADDITIONAL CHARGOR**

**2.1 Accession**

Each Additional Chargor agrees to be a Chargor for the purposes of the Debenture with immediate effect and agrees to be bound by all of the terms of the Debenture as if it had originally been a party to it as an Original Chargor (but so that the Security created by virtue of this security accession deed shall be created on the date of this Deed)

**2.2 Consent of existing Chargors**

The Parent agrees and consents, for itself and on behalf of each of the other existing Chargors, to the terms of this Security Accession Deed and further agrees that its

execution shall not, in any way, prejudice or affect the Security granted by each of the existing Chargors pursuant to (and the covenants given by each of them in) the Debenture

## 2.3 Covenant to pay

Each Additional Chargor covenants with the Security Agent as security agent for the Secured Parties that it shall on demand of the Security Agent discharge (i) all the Secured Liabilities, and (ii) all other present and future debts and obligations at any time due, owing or incurred by any member of the Restricted Group and by each Obligor to any Secured Party under the relevant Debt Documents (including this Debenture and any Mortgage), both actual and contingent and whether incurred solely or jointly and as principal or surety or in any other capacity and each Additional Chargor shall pay to the Security Agent when due and payable every sum (without double counting) at any time owing, due or incurred by it to the Security Agent (whether for its own account or as security agent for the Secured Parties) or any Receiver in respect of any such liabilities **provided that** neither such covenant nor the security constituted by this Debenture or any Mortgage shall extend to or include any liability or sum which would, but for this proviso, cause such covenant or security to be unlawful or prohibited by any applicable law (the "**Secured Obligations**")

## 2.4 Fixed charges

Subject to Clause 1.11 (*Excluded Assets*) of the Debenture:

- (a) Each Additional Chargor charges with full title guarantee in favour of the Security Agent as security agent for the Secured Parties for the payment and discharge of the Secured Obligations, by way of first fixed charge (which shall be a charge by way of first legal mortgage) the Real Property
- (b) Each Additional Chargor charges with full title guarantee in favour of the Security Agent as security agent for the Secured Parties for the payment and discharge of the Secured Obligations, by way of first fixed charge all such Additional Chargor's right, title and interest from time to time in and to the Tangible Moveable Property
- (c) Each Additional Chargor charges with full title guarantee in favour of the Security Agent as security agent for the Secured Parties for the payment and discharge of the Secured Obligations, by way of first fixed charge all such Additional Chargor's right, title and interest from time to time in and to the Accounts.
- (d) Each Additional Chargor charges with full title guarantee in favour of the Security Agent as security agent for the Secured Parties for the payment and discharge of the Secured Obligations, by way of first fixed charge all such Additional Chargor's right, title and interest from time to time in and to the Intellectual Property
- (e) Each Additional Chargor charges with full title guarantee in favour of the Security Agent as security agent for the Secured Parties for the payment and discharge of the Secured Obligations, by way of first fixed charge all such

Additional Chargor's right, title and interest from time to time in and to any goodwill and only in rights in relation to the uncalled capital of that Additional Chargor.

- (f) Each Additional Chargor charges with full title guarantee in favour of the Security Agent as security agent for the Secured Parties for the payment and discharge of the Secured Obligations, by way of first fixed charge all such Additional Chargor's right, title and interest from time to time in and to the Investments
- (g) Each Additional Chargor charges with full title guarantee in favour of the Security Agent as security agent for the Secured Parties for the payment and discharge of the Secured Obligations, by way of first fixed charge all such Additional Chargor's right, title and interest from time to time in and to the Shares, all dividends, interest and other monies payable in respect of the Shares and all other Related Rights (whether derived by way of redemption, bonus, preference, option, substitution, conversion, compensation or otherwise)
- (h) Each Additional Chargor charges with full title guarantee in favour of the Security Agent as security agent for the Secured Parties for the payment and discharge of the Secured Obligations, by way of first fixed charge all such Additional Chargor's right, title and interest from time to time in and to all Monetary Claims and all Related Rights other than any claims which are otherwise subject to a fixed charge or assignment (at law or in equity) pursuant to this deed.

## **2 5 Floating charge**

- (a) Each Additional Chargor with full title guarantee charges in favour of the Security Agent as security agent for the Secured Parties with the payment and discharge of the Secured Obligations by way of first floating charge all present and future assets and undertaking of such Additional Chargor
- (b) The floating charge created by sub-clause (a) above shall be deferred in point of priority to all fixed Security validly and effectively created by each Additional Chargor under the Primary Finance Documents in favour of the Security Agent as security agent for the Secured Parties as security for the Secured Obligations
- (c) Paragraph 14 of Schedule B1 to the Insolvency Act 1986 applies to the floating charge created pursuant to this Clause 2 5 (*Floating Charge*)

**2.6 Security Assignment**

Subject to Clause 1.11 (*Excluded Assets*) of the Debenture, each Additional Chargor assigns and agrees to assign absolutely with full title guarantee to the Security Agent as security agent for the Secured Parties as security for the payment and discharge of the Secured Obligations all of such Additional Chargor's right, title and interest from time to time in and to each of the following assets (subject to obtaining any necessary consent to that assignment from any third party)

- (a) the proceeds of any Insurance Policy and all Related Rights, and
- (b) each Intercompany Loan Agreement.

**3 CONSTRUCTION OF DEBENTURE**

- (a) The Debenture and this deed shall be read together as one instrument on the basis that references in the Debenture to "this Debenture" will be deemed to include this deed.
- (b) This Deed is a Finance Document
