IT IS ORDERED that

- 1. Each of the cases listed in the Schedules (attached to this Order) (the **Block Transfer Cases**) be transferred to the High Court of Justice, Chancery Division, Business and Property Courts in Manchester for the purpose only of making this Order.

- 4. Deviesh Raikundalia, Glen Carter, James Hawksworth, Matthew Wild, Terence Guy Jackson and Karen Spears all of RSM (the Replacement Officeholders) be appointed as replacement officeholders in respect of each of the relevant Block Transfer Cases from the date of this Order

pursuant to Rule 12.37(3) of the Rules without being required to (i) use one of the decision procedures or deemed consent procedures set out in the Rules for the Block Transfer Cases; or (ii) file a receipts and payments account.

- 5. The creditors or, in the case of the members' voluntary liquidations any member, in each of the Block Transfer Cases will be notified of this Order by way of one composite advertisement published in the London Gazette (the **Advertisement**) within 14 days of receipt of the sealed Order from the Court and at the time of the next statutory reporting required for each of the Block Transfer Cases.
- 6. Any creditor or, in the case of the members' voluntary liquidations any member, in respect of any of the companies listed in the Block Transfer Cases who has an objection to this Order, shall have 28 days from the date notice is given to creditors, in accordance with paragraph 5 of this Order to apply to Court to set aside or vary the terms of this Order. Such application shall not affect the transfer of the Block Transfer Cases until further or other Order by the Court.
