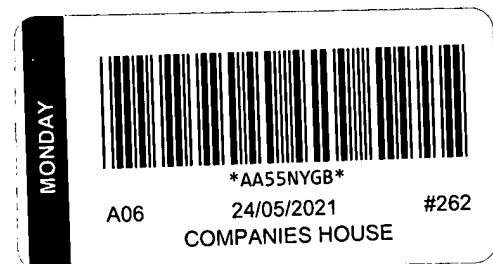

DIRECTORS' REPORT

The directors of Sixty Seven Nominees Limited ("the Company") present their annual report together with the financial statements for the year ended 31 December 2020.

ACTIVITIES AND BUSINESS REVIEW

The Directors' report has been prepared in accordance with the special provisions available to companies entitled to the small companies exemption and therefore does not include a Strategic report.

Principal activity

The Company is a dormant subsidiary of NatWest Markets Plc which provides the Company with direction and access to all central resources. "The Group" comprises NatWest Markets Plc, its subsidiary and associated undertakings.

Status review

The Company has not traded during the accounting period. It received no income and incurred no expenditure and consequently has made neither a profit nor a loss. A Profit and Loss Account is therefore not presented.

At the end of the year total assets were £100 (2019: £100).

Dividends

The directors do not recommend the payment of a dividend (2019: nil).

Principal risks and uncertainties

The Company is part of NatWest Group plc (formerly known as The Royal Bank of Scotland Group plc) which has established a comprehensive framework for managing risks, which is continually evolving as business activities change in response to market, credit, product and other developments.

The Company is only exposed to risk or uncertainty in relation to balances with members of NatWest Group plc. As a result disclosures relating to risk and capital management have not been included.

Going concern

The directors, having a reasonable expectation that the Company has adequate resources to continue in operational existence for the foreseeable future, have prepared the financial statements on a going concern basis.


The directors are responsible for preparing the annual report and the financial statements in accordance with applicable law and regulations.

They are also responsible for safeguarding the assets of the Company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.



The financial statements are prepared:

- on a going concern basis;
- under Financial Reporting Standard (FRS) 101 *Reduced Disclosure Framework* and in accordance with International Financial Reporting Standards issued in conformity with the requirements of the Companies Act 2006; and
- on the historical cost basis.

The Company meets the definition of a qualifying entity under FRS 100 Application of Financial Reporting Requirements issued by the Financial Reporting Council.

The Company is incorporated in the UK and registered in England and Wales and the financial statements are presented:

- in accordance with the Companies Act 2006;
- in sterling which is the functional currency of the Company

The few changes to IFRS that were effective from 1 January 2020 have had no material effect on the Company's financial statements for the year ended 31 December 2020.


