* Directorships.—The names of all bodies corporate incorporated in Great Britain of which the director is also a director should be given, except bodies corporate which the company making the return is the wholly-owned subsidiary or bodies corporate which are the wholly-owned subsidiary either of the company or of another company of which the company is the wholly-owned subsidiary. A body corporate is deemed to be the wholly-owned subsidiary of another if it has no members except that other and that other's wholly-owned subsidiaries and its or their nominees. If the space provided in the form is insufficient, particulars of other directorships should be listed on a separate statement attached to this form.
