

1. ACCOUNTING POLICIES

(a) Basis of Accounting

The accounts have been prepared under the historical cost convention.

(b) Turnover

Turnover represents the amount receivable for services supplied, excluding value added tax.

(c) Tangible Fixed Assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life:

Plant	-	20% on cost
Commercial vehicles	-	25% on cost
Motor cars	-	25% on cost
Office equipment	-	20% on cost
