DIRECTORS' REPORT

The Directors submit their annual report together with the audited accounts of the Company for the year ended 31 December 1987.

ACTIVITIES During the year the Company ceased to advise on and monitor the UK banking business of the Earclays Group. On 7 December 1987 the Company ceased to be an authorised institution within the terms of the Banking Act 1987. The deposits previously accepted by the Company have been taken over by Barclays Bank PLC.

SUBSEQUENT EVENTS

On 1 January 1988 the Company issued 30,000,000 shares of £1 each to Barclays Bank PLC as the purchase price for Barclays Bank PLC's investment in Mercantile Credit Company Limited, and on the same date the Company was re-registered as a public company and changed its name to Mercantile Group PLC.

RESULTS AND DIVIDEND

The Directors report that the Company has made neither profit nor loss on transactions entered into during the year ended 31 December 1987. The Directors do not recommend the payment of a dividend.
