
For the year ended 31 March 2008 the Company was dormant and entitled to exemption under section 249AA(1) of the Companies Act 1985.

All the ordinary shares of Guardian Media Group plc are owned by the Scott Trust. The Directors regard Eden 2 & Cie SCA as the ultimate controlling party.
