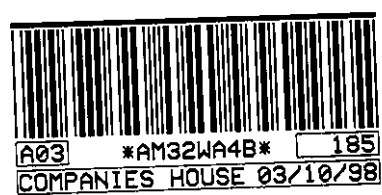

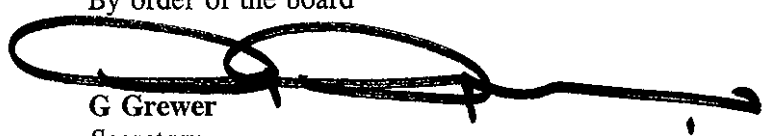
Statement of directors' responsibilities
