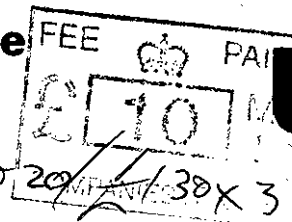

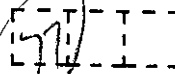

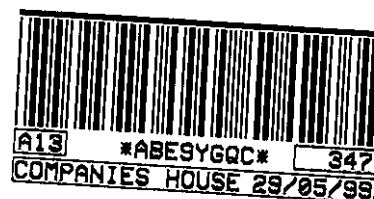

1.
