Sale of KPMG's restructuring turnaround business

As previously reported, KPMG LLP sold its restructuring turnaround business to Interpath Ltd, a new company backed by HIG Capital, on 4 May 2021.

The declaration of solvency, sworn by the directors prior to the commencement of the liquidation, showed a debt of £50,000 due from Parker Hannifin Manufacturing Limited ('PHML') ('the Debt'), the Company's immediate parent. The Debt has been distributed to PHML by set-off (see 'Distributions' below).

Creditors

The Company had no known creditors.

Notices to creditors to prove their claims in the liquidation were advertised in the London Gazette and The Times on 3 October 2015. No creditors were forthcoming as a result of these advertisements.

Tax

The Company's tax advisors advised that the Company had dormant corporation tax status. HM Revenue & Customs ('HMRC') submitted a claim in the liquidation in respect of unpaid tax, which was settled (plus statutory interest) by PHML on behalf of the Company.

The Joint Liquidators have sought and received confirmation from HMRC that the Company has no outstanding corporation tax returns or liabilities, that it will not raise

enquiries into any pre or post liquidation periods and that it has no objection to the Joint Liquidators proceeding to finalise the liquidation.

A similar assurance was sought and received from HMRC in respect of PAYE and VAT matters.

Post liquidation VAT in the sum of £1,713.00 was reclaimed by the Joint Liquidators on behalf of the Company, which will be paid by HMRC directly to PHML.

Distributions

On 6 April 2022, the Joint Liquidators declared a first and final distribution of the assets of the Company to PHML, as the sole beneficial shareholder of the Company.

The distribution was at the rate of £50,000 per £1 Ordinary share and was effected by set off against the debt of £50,000 due to the Company by PHML.

Joint Liquidators' remuneration and expenses

A written resolution was passed on 19 October 2015 that the remuneration of the Joint Liquidators be fixed at their normal charging rates according to the time properly spent by them and members of their staff in attending to matters arising in the winding up of the Company.

During the period since the anniversary of the liquidation, the Joint Liquidators' remuneration and expenses totalling £8,565.00 have been paid by PHML.
