1. PURPOSE OF REPORT

This report has been prepared in accordance with insolvency legislation to provide members and the registrar of companies with information relating to the progress of the liquidation in the period from 14 June 2011 to 13 June 2012, but also takes into account subsequent issues arising up to the date of reporting

This report has been prepared solely to comply with the statutory requirements of Section 92A of the Insolvency Act 1986 and Rule 4.49C of the Insolvency Rules 1986 (as amended) It has not been prepared for use in respect of any other purpose, or to inform any investment decision in relation to any debt or financial interest in the company Neither the Liquidators' nor Baker Tilly Restructuring and Recovery LLP accept any liability whatsoever arising as a result of any decision or action taken or refrained from as a result of information contained in this report.

2. PROGRESS OF THE LIQUIDATIONS

2.1. Payments to creditors

Each of the companies in the Dormant Companies Group were dormant and the directors were unaware of any creditors that may have claims in the liquidations. To date, HM Revenue & Customs ("HMRC") has confirmed in some cases it has no claim against certain companies within the Dormant Companies Group. We have set out below the progress in this regard;

It is the Liquidators' intention to distribute the intercompany assets in specie upon receipt of tax clearance from HMRC and final matters preventing closure have been resolved.

3. DISTRIBUTIONS TO SHAREHOLDERS

To date, no distributions have been made to shareholders. It is anticipated that following the resolution of the outstanding matters outlined below in section 4 there will be a distribution in specie made to the shareholders of each of the respective companies.

4. MATTERS PREVENTING CLOSURE

Due to certain intercompany relationships affecting the distributions it was originally considered appropriate to close all liquidations together, however, due to the length of time the liquidations have been open, we will look to start closing individual liquidations in the near future.

Marshall's Hoveringham Limited

Personal Injury Claims

Two former employees of Marshall's Hoveringham Limited ("Hoveringham") have submitted damages claims against Hoveringham. These are in respect of alleged noise induced hearing damage. These claims have been referred to Marshall's plc for onward transmission to their claims handlers/insurers.

Claim 1

The Company secretary of Hoveringham has advised that one of the claims was not a formal complaint and following the provision of information requested to the "claimant" solicitor nothing further has been heard in this regard.

Claim 2

All relevant information has been provided to the insurers and to date we have not heard back. The Company secretary advised that we should keep our files open for 18 months from the date the information was sent as that is how long the insurer would keep their file open for. As such we expect to be able to finalise this matter by 1 January 2013

Marshall's Group

Tax Clearance

We have requested written tax clearance from HMRC in respect of all the companies in the Dormant Companies Group. It will not be possible to conclude the liquidation of the Dormant Companies Group until such point as written tax clearance has been obtained from all Crown departments. 5. RECEIPTS AND PAYMENTS SUMMARY

There have been no receipts or payments made during the course of the liquidations. Attached are the abstracts of receipts & payments at Appendix E to this report as evidence of same. You will note that the only assets to be realised are intercompany debtors.

6. COSTS AND JOINT LIQUIDATORS' REMUNERATION

6.1. Joint Liquidators' Remuneration and Disbursements

The Joint Liquidators' remuneration was approved on a time cost basis by the shareholders on 14 June 2010. A cap of £25,000 has been placed on the Joint Liquidators' remuneration. We have incurred time costs of £18,036.50 since the date of our appointment in respect of the Dormant Companies Group. Additionally, we have incurred pre-appointment time-costs of £14,069.00, resulting in total time costs to date of £32,105.50. To date, we have not drawn any remuneration in respect of time costs incurred. An analysis of time incurred in the period is attached at Appendix D.

Approval was also given to the drawing of disbursements, including category 2 disbursements. To date, total disbursements of £1,664.06 have been incurred and remain unpaid.

7. JOINT LIQUIDATORS' STATEMENT OF EXPENSES

No expenses have been incurred in the period of the report.

8. MEMBERS' RIGHT TO INFORMATION AND ABILITY TO CHALLENGE REMUNERATION AND EXPENSES

In accordance with the provisions of Rules 4.49E and 4.148C of the Insolvency Rules 1986 members have a right to request further information about remuneration or expenses and to challenge such remuneration or expenses

A request for further information must be made in writing within 21 days of receipt of this report

Members of the company with at least 10% of the total voting rights of all members having the right to vote at general meetings of the company, or any members with the permission of the court, may apply to court that the remuneration charged, the basis fixed or expenses incurred by the liquidator are in all the circumstances excessive

Any such challenge must be made no later than eight weeks after receipt of the report which first discloses the charging of remuneration or incurring of the expenses in question.

Charging policy

- Partners, directors, managers, administrators, cashiers, secretarial and support staff are allocated an hourly charge out rate which is reviewed from time to time
- Work undertaken by cashiers, secretarial and support staff will be or has been charged for separately and such work will not or has not also been charged for as part of the hourly rates charged by partners, directors, managers and administrators
- Time spent by partners and all staff in relation to the insolvency estate is charged to the estate
- Time is recorded in 6-minute units at the rates prevailing at the time the work is done
- The current charge rates for Baker Tilly Restructuring and Recovery LLP London are attached
- Time billed is subject to Value Added Tax at the applicable rate.
- It is the office holder's policy to ensure that work undertaken is carried out by the appropriate grade of staff required for each task, having regard to its complexity and the skill and experience actually required to perform it
- Baker Tilly Restructuring and Recovery LLP's charge out rates are reviewed periodically

Expenses and disbursements policy

- Only expenses and disbursements properly incurred in relation to an insolvency estate are re-charged to the insolvency estate
- Expenses and disbursements which comprise external supplies of incidental services specifically identifiable to the insolvency estate require disclosure to members, but do not require members' approval prior to being drawn from the insolvency estate. These are known as "Category 1" disbursements.
- Expenses and disbursements which are not capable of precise identification and calculation (for example any which include an element of shared or allocated costs) require the approval of members prior to being drawn from the insolvency estate. These are known as "Category 2" disbursements
