- 2 where the Respondent(s) are appointed as joint liquidator or joint administrator, as the case may be, the joint liquidator or joint administrator as the case may be, have the power to act jointly and severally so that all functions may be exercised by any or all of them,
- 3 the proceedings listed in the schedules numbered 1 to 9 attached to this Order (the "Schedules") be transferred to the Companies Court of the Chancery Division of The Royal Courts of Justice for the purpose only of the Application and thereafter be transferred back, and Ms Singh-Sall does ensure that a sealed copy of this Order be lodged with the court having jurisdiction over each case affected by it for filing on the court file relating to that case,

6. Ms Singh-Sall shall be removed from office as joint administrator of the company listed in Schedule 2A hereto as being in administration,
7. Mr Jeremy Mark Willmont shall remain in office as sole administrator of the company listed in Schedule 2A hereto as being in administration,
8. Ms Singh-Sall shall be removed from office as sole trustee in bankruptcy of the individuals listed in Schedule 3 hereto,
9. Mr Stephen Anthony John Ramsbottom, of Moore Stephens LLP, shall be appointed as sole trustee in bankruptcy of the individuals listed in Schedule 3 hereto, in substitution of Ms Singh-Sall,
10. Ms Singh-Sall shall be removed from office as joint trustee in bankruptcy of the individuals listed in Schedules 4 and Schedule 5 hereto,
11. Mr Stephen Anthony John Ramsbottom, of Moore Stephens LLP, shall be appointed as joint trustee in bankruptcy of the individuals listed in Schedules 4 and 5 hereto, in substitution of Ms Singh-Sall,
12. Ms Singh-Sall shall be removed from office as joint liquidator of the companies identified in Schedules 6 and 7 hereto as being in Creditors' Voluntary Liquidation,
13. Mr Stephen Anthony John Ramsbottom, of Moore Stephens LLP, shall be appointed as joint liquidator of the companies listed in Schedules 6 and 7 hereto as being in Creditors' Voluntary Liquidation, in substitution of Ms Singh-Sall;
14. Ms Singh-Sall shall be removed from office as joint liquidator of the company identified in Schedule 8 hereto as being in Members' Voluntary Liquidation,

- 17 Mr Stephen Anthony John Ramsbottom, of Moore Stephens LLP, shall be appointed as joint liquidator of the companies identified in Schedule 9 hereto, as being subject to a Compulsory Liquidation in substitution of Ms Singh-Sall,
- 18 Ms Singh-Sall shall be released from all liability both in respect of all her acts and omissions in the administration of her cases and otherwise in relation to her conduct as office holder of the companies and individuals as are listed in the Schedules hereto
- a) by the creditors of the relevant estates, with effect from 28 days after the relevant notice referred to in paragraph 21 below has been given to creditors,
 - b) by the Secretary of State, with effect from 42 days after the relevant notice referred to in paragraph 21 below has been advertised,
- save where a creditor or the Secretary of State notifies Ms Singh-Sall or (where appropriate) her joint appointee or replacement office holder of any claim, whereupon the time period for such release shall be the final resolution of such purported claim and, in relation to bankruptcy number 2563 of 2013 in Central London County Court, (Richard Keates), that the time period for such release shall be the later of (i) the date the trustees in bankruptcy of bankruptcy number 2563 of 2013 in Central London County Court, (Richard Keates) are released from liability pursuant to section 299 of the Insolvency Act 1986, and (ii) four calendar months after the determination, discontinuance, abandonment, dismissal, settlement or other final disposal of the Court proceedings under claim number A6QZ1437

 - i the costs of complying with a request of the committee or creditor for an account of Ms Singh-Sall's administration should be an expense of the insolvency proceedings,
 - ii the fact that the creditors have the right to object and make representations to the Secretary of State in respect of Ms Singh-Sall's release within 28 days after the notice has been advertised,

iii the fact that Ms Singh-Sall will be entitled to apply to the Secretary of State for her release within 42 days after the notice has been advertised, and
