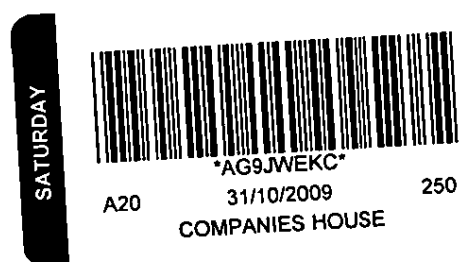

PRINCIPAL ACTIVITY


The company's principal activity continues to be that of the management and maintenance of the property at 90 Pembroke Road, Bristol.
