

AND UPON the Claimant and the Registrar of Companies (the Defendant) both acting by their solicitor consenting to this Order

IT IS ORDERED THAT:


- (1) the name of the above named Power Transformers (Birmingham) Limited be restored to the Register of Companies
- (2) the Company do continue in Creditors' Voluntary Liquidation
- (3) the Claimant do serve a copy of the Order on the Company's former Liquidator within 21 days of the date hereof

- (4) if at the date of registration of this Order with the Registrar of Companies the name of the Company is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the Company to 01258201 Limited
- (5) an Office Copy of the Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the Company is thereupon to be deemed to have continued in existence as if its name had not been struck off





(7) the hearing fixed for the 3 March 2017 at 2:00 pm be vacated
