The director does not recommend the payment of a dividend (2017: £nil).



## NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 DECEMBER 2018

### 1. GENERAL INFORMATION

Garfunkels Restaurants Limited (Company Registration number 01275016) is a private Company, limited by shares and is incorporated and domiciled in England and Wales. The registered office is 5-7 Marshalsea Road, Borough, London SE1 1EP.

### 2. ACCOUNTING POLICY

#### Accounting convention

The accounts have been prepared under the historical cost convention and in accordance with applicable accounting standards. Garfunkels Restaurants Limited is a non-trading company and is in a net assets position. The Company is part of The Restaurant Group plc group which the Director believes, having made enquiries, has sufficient financial resources and has committed to provide financial support for at least the next twelve months. As a consequence, the Director believes that the Company is well placed to manage its business risks successfully. Therefore the Director has a reasonable expectation that the Company has adequate resources to continue in operational existence for the foreseeable future. Accordingly, they continue to adopt the going concern basis in preparing the annual report and accounts.

The Company has adopted Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland'. As permitted under FRS 102, the Company has elected to retain its accounting policies for reported assets, liabilities and equity at the date of transition to this FRS until there is any change to those balances or the Company undertakes new transactions.

There have been no cash movements and no changes in equity in either the current or the preceding year and accordingly no Statement of Cash Flows or Statement of Changes in Equity is presented.

The company has no employees. The director is remunerated by the parent undertaking.
