AND the Claimant undertaking that:

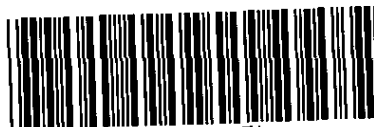
(A) the Company will not carry on business or operate in any way other than to take the necessary steps to;

AND UPON the Claimant and the solicitors for the Registrar of Companies (the Defendant) both consenting to this Order

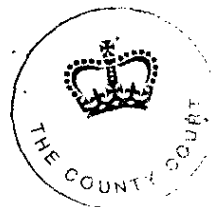
IT IS ORDERED THAT:
